

1 Introduction

1.1 Product Specification

The pneumatic stripping machine is a pneumatic cable stripping machine built as a complete table unit. It strips cable \emptyset of 4-15mm or 6-70mm² (AWG 9-2/0).

All other applications of the pneumatic stripping machine are prohibited. For all unauthorized applications of the pneumatic stripping machine, the manufacturer cannot be held liable for any resultant damage or injury.

1.2 Conformity



The machine may only be used for the purpose specified in the operating instruction. The manufacturers and suppliers will not be liable for any damages which may result due to the machine being used for a purpose other than that for which it was intended. This is done entirely at the user's own risk.

2 Safety



6.2.1 Exchange of Knives


To exchange the knives, proceed as follows (See Figures 6.2.1 and 6.2.2):

- Disconnect the machine from the pneumatic air supply.
- Unscrew the two knurled head screws (1) and remove the safety guard.
- Open the screw (2) of the knife holder.
- Take out the knife holder.
- Choose the correct knife that corresponds to the cable.
- · Insert and position the knife.
- Tighten the screws of the knife (3).




- By tightening or loosening the four screws (2) at the side of the knife holder, the knives can be adjusted 0.5mm per knife to the center.
- Reinsert the knife holder and tighten screw (2).
- Mount the safety guard and tighten the knurled head screws (1).



To mount the centering guide, please proceed as follows (See Figures 6.2.3 and 6.2.4):

- Disconnect the machine from the pneumatic air supply.
- Unscrew the two knurled head screws (1), and remove the safety guard.
- Open the screw (2) of the knife holder.
- Take out the knife holder.
- Open the locking screw (2) of the centering guide.
- Chose the correct centering guide.
- Pull out the centering guide (3) inwardly.
- Mount the new centering guide (3).
- Tighten it lightly with the locking screw (2).
- Mount the safety guard, and tighten the screws (1).








6.3 Machine Setup Adjustments

6.3.1 Stripping Length

To set the stripping length, proceed as follows (See Figure 6.3.1):

- Loosen the adjustment screw for the stripping length (4).
- Adjust the required stripping length by sliding it to the correct position.
- Tighten the adjustment screw (4).



6.3.2 Adjustment Screw for Blade Opening

Adjust the hex screw (1) with the 4mm hex key until the blade opening matches the outside diameter of the cable to be processed. See Figure 6.3.2.

- Turning the screw clockwise enlarges the opening of the blades.
- Turning the screw counterclockwise makes it smaller.



- Mount the suitable knife (4-15mm) and centering guide.
- Push the cable between the cable clamps through the centering guide until it stops.
- Keep hold of the cable.
- Press the pneumatic foot pedal to start the stripping process.
- Pull out the cable.




