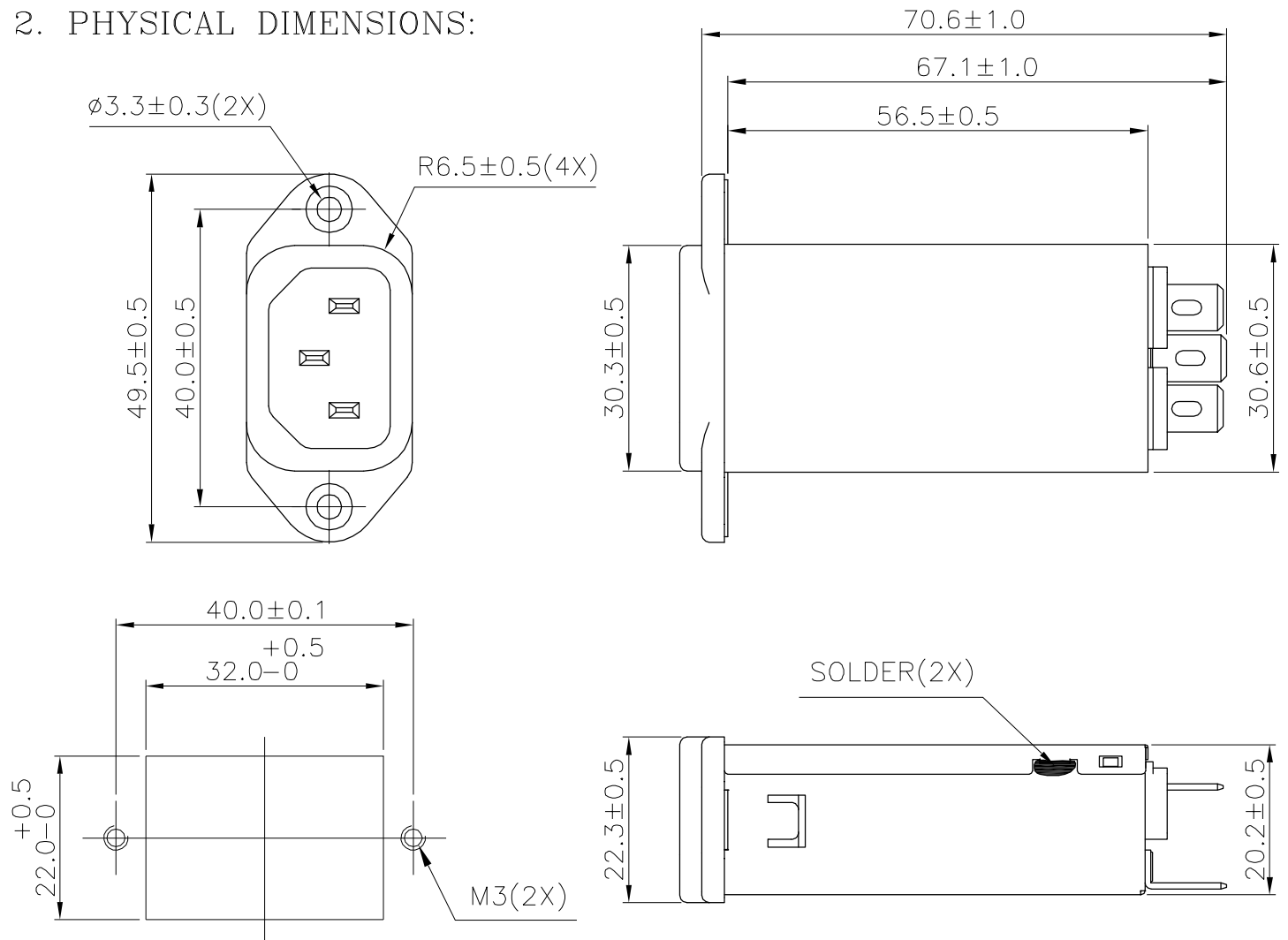

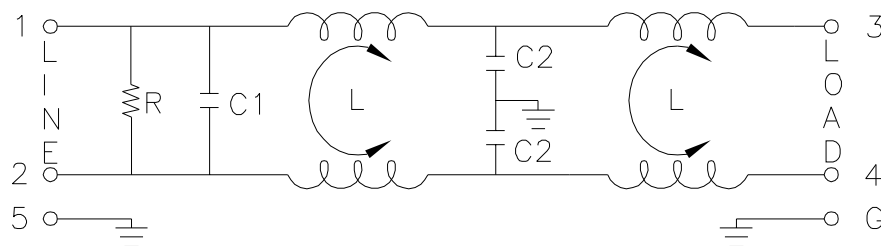
## 2. PHYSICAL DIMENSIONS:
