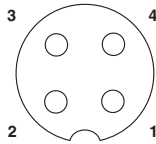

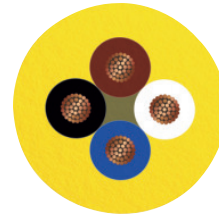

Schematic diagram



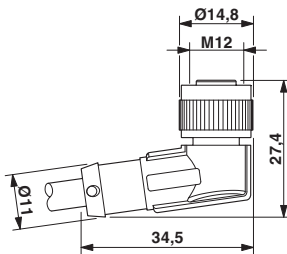
Pin assignment M12 socket, 4-pos., A-coded, view female side

Cable cross section



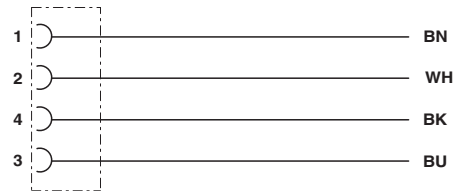
PVC yellow 105 °C [547]
