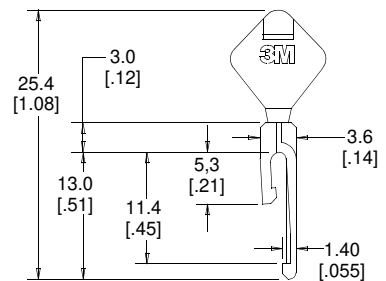
Recommended Mounting Hole Pattern
