## **Description**


The Advanced Ultra Low Power (AUP) CMOS logic family is designed for low power and extended battery life in portable applications.

The 74AUP2G32 is a dual two input OR gate. Both gates have push-pull outputs designed for operation over a power supply range of 0.8V to 3.6V. The device is fully specified for partial power down applications using  $l_{\rm OFF}$ . The  $l_{\rm OFF}$  circuitry disables the output preventing damaging current backflow when the device is powered down. Each gate performs the positive Boolean function:

$$Y=A+B \ \text{or} \ Y=\overline{\overline{A}\bullet \overline{B}}$$







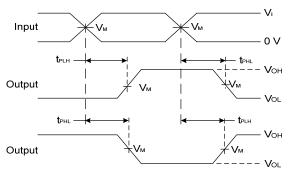
