The 74AXP2G3404 is a single buffer and single inverter.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device ensures very low static and dynamic power consumption across the entire V_{CC} range from 0.7 V to 2.75 V. It is fully specified for partial power down applications using I_{OFF}. 













Fig 9. Additional tpd versus load capacitance





Fig 10. Additional tpd versus load capacitance








Fig 13. Package outline SOT886 (XSON6)




Fig 14. Package outline SOT1115 (XSON6)




Fig 15. Package outline SOT1202 (XSON6)
