1. General description

The 74HC377; 74HCT377 is an octal positive-edge triggered D-type flip-flop. The device features clock (CP) and data enable (\overline{E}) inputs. When \overline{E} is LOW, the outputs Qn assume the state of their corresponding Dn inputs that meet the set-up and hold time requirements on the LOW-to-HIGH clock (CP) transition. Input \overline{E} must be stable one set-up time prior to the LOW-to-HIGH transition for predictable operation. Inputs include clamp diodes that enable the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .







The shaded areas indicate when the input is permitted to change for predictable output performance.



Fig 8. Test circuit for measuring switching times




Fig 9. Package outline SOT163-1 (SO20)


Fig 10. Package outline SOT339-1 (SSOP20)
