



Pad Assignments for DQFN





Functional Description

The LCX573 contains eight D-type latches with 3-STATE output buffers. When the Latch Enable (LE) input is HIGH, data on the D_n inputs enters the latches. In this condition the latches are transparent, i.e., a latch output will change state each time its D input changes. When LE is LOW the latches store the information that was present on the D inputs a setup time preceding the HIGH-to-LOW transition of LE. The 3-STATE buffers are controlled by the Output Enable $(\overline{\mathsf{OE}})$ input. When $\overline{\mathsf{OE}}$ is LOW, the buffers are enabled. When $\overline{\mathsf{OE}}$ is HIGH the buffers are in the high impedance mode but this does not interfere with entering new data into the latches.






Figure 1. AC Test Circuit (C_L includes probe and jig capacitance)




Waveform for Inverting and Non-Inverting Functions




Propagation Delay, Pulse Width and $t_{rec} \, \text{Waveforms}$




3-STATE Output Low Enable and Disable Times for Logic


Setup Time, Hold Time and Recovery Time for Logic


Figure 3. 20-Lead Small Outline Integrated Circuit (SOIC), JEDEC MS-013, 0.300" Wide




Figure 4. 20-Lead Small Outline Package (SOP), EIAJ TYPE II, 5.3mm Wide


