






Fig 7. Package outline SOT363 (SC-88)





Fig 8. Package outline SOT457 (SC-74)




XSON6: plastic extremely thin small outline package; no leads; 6 terminals; body 1 x 1.45 x 0.5 mm



Fig 10. Package outline SOT891 (XSON6)


