## THERMAL DATA

Absolute maximum ratings apply individually only, not in combination.
The ADP222/ADP223/ADP224/ADP225 can be damaged when the junction temperature limits are exceeded. Monitoring ambient temperature does not guarantee that $\mathrm{T}_{\mathrm{J}}$ is within the specified temperature limits. In applications with high power dissipation and poor thermal resistance, the maximum ambient temperature may have to be derated. In applications with moderate power dissipation and low PCB thermal resistance, the maximum ambient temperature can exceed the maximum limit as long as the junction temperature is within specification limits.
The junction temperature $\left(\mathrm{T}_{\mathrm{J}}\right)$ of the device is dependent on the ambient temperature $\left(\mathrm{T}_{\mathrm{A}}\right)$, the power dissipation of the device $\left(\mathrm{P}_{\mathrm{D}}\right)$, and the junction-to-ambient thermal resistance of the package $\left(\theta_{J A}\right)$. Maximum junction temperature $\left(T_{J}\right)$ is calculated from the ambient temperature $\left(\mathrm{T}_{\mathrm{A}}\right)$ and power dissipation $\left(\mathrm{P}_{\mathrm{D}}\right)$ using the formula

Junction-to-ambient thermal resistance $\left(\theta_{\mathrm{JA}}\right)$ of the package is based on modeling and calculation using a 4-layer board. $\theta_{\mathrm{JA}}$ is highly dependent on the application and board layout. In applications where high maximum power dissipation exists, close attention to thermal board design is required. The value of $\theta_{\text {JA }}$ may vary, depending on PCB material, layout, and environmental conditions. The specified value of $\theta_{\mathrm{JA}}$ is based on a 4-layer, $4 \mathrm{in} \times 3 \mathrm{in}, 2^{112}$ oz copper board, as per JEDEC standards. For more information, see the AN-772 Application Note, A Design and Manufacturing Guide for the Lead Frame Chip Scale Package (LFCSP).
$\Psi_{J B}$ is the junction-to-board thermal characterization parameter with units of ${ }^{\circ} \mathrm{C} / \mathrm{W} . \Psi_{J B}$ of the package is based on modeling and calculation using a 4-layer board. The JESD51-12, Guidelines for Reporting and Using Package Thermal Information, states that thermal characterization parameters are not the same as thermal resistances. $\Psi_{\text {Jв }}$ measures the component power flowing through multiple thermal paths rather than a single path as in thermal resistance, $\theta_{\text {JB. }}$. Therefore, $\Psi_{\text {IB }}$ thermal paths include convection from the top of the package as well as radiation from the package, factors that make $\Psi_{\text {IB }}$ more useful in real-world applications. Maximum junction temperature $\left(\mathrm{T}_{\mathrm{J}}\right)$ is calculated from the board temperature $\left(\mathrm{T}_{\mathrm{B}}\right)$ and power dissipation $\left(\mathrm{P}_{\mathrm{D}}\right)$ using the formula

## THEORY OF OPERATION

The ADP222/ADP223/ADP224/ADP225 are low quiescent current, fixed and adjustable dual output, low dropout linear regulators that operate from 2.5 V to 5.5 V and provide up to 300 mA of current from each output. Drawing a low $300 \mu \mathrm{~A}$ quiescent current (typical) at full load make the ADP222/ ADP223/ADP224/ADP225 ideal for battery-operated portable equipment. Shutdown current consumption is typically 200 nA .
Optimized for use with small $1 \mu \mathrm{~F}$ ceramic capacitors, the ADP222/ADP223/ADP224/ADP225 provide excellent transient performance.

Internally, the ADP222/ADP223/ADP224/ADP225 consist of a reference, two error amplifiers, and two PMOS pass transistors. Output current is delivered via the PMOS pass device, which is
controlled by the error amplifier. The error amplifier compares the reference voltage with the feedback voltage from the output and amplifies the difference. If the feedback voltage is lower than the reference voltage, the gate of the PMOS device is pulled lower, allowing more current to flow and increasing the output voltage. If the feedback voltage is higher than the reference voltage, the gate of the PMOS device is pulled higher, allowing less current to flow and decreasing the output voltage.

The ADP223/ADP225 are exactly the same as the ADP222/ ADP224 except that the output voltage dividers are internally disconnected and the feedback input of the error amplifiers is brought out for each output. The output voltages can be set according to the following equations:

$$
\begin{aligned}
& V_{\text {out1 }}=0.50 \mathrm{~V}(1+R 2 / R 1) \\
& V_{\text {out } 2}=0.50 \mathrm{~V}(1+R 3 / R 4)
\end{aligned}
$$

The value of R 1 and R 4 should be less than $200 \mathrm{k} \Omega$ to minimize errors in the output voltage caused by the ADJx pin input current. For example, when R1 and R2 each equal $200 \mathrm{k} \Omega$, the output voltage is 1.0 V . The output voltage error introduced by the ADJx pin input current is 2 mV or $0.20 \%$, assuming a typical ADJx pin input current of 10 nA at $25^{\circ} \mathrm{C}$.
The output voltage of the ADP223/ADP225 may be set from 0.5 V to 5.0 V .

The ADP222/ADP224 are available in multiple output voltage options ranging from 0.8 V to 3.3 V .

The ADP224/ADP225 are identical to the ADP222/ADP223 with the addition of a quick output discharge (QOD) feature. This allows the output voltage to start up from a known state.
The ADP222/ADP223/ADP224/ADP225 use the EN1/EN2 pins to enable and disable the VOUT1/VOUT2 pins under normal operating conditions. When EN1/EN2 are high, VOUT1/VOUT2 turn on; when EN1/EN2 are low, VOUT1/VOUT2 turn off. For automatic startup, EN1/EN2 can be tied to VIN.

## APPLICATIONS INFORMATION

## CAPACITOR SELECTION

## Output Capacitor

The ADP222/ADP223/ADP224/ADP225 are designed for operation with small, space-saving ceramic capacitors but function with most commonly used capacitors as long as care is taken with regard to the effective series resistance (ESR) value. The ESR of the output capacitor affects the stability of the LDO control loop. A minimum of $0.7 \mu \mathrm{~F}$ capacitance with an ESR of $1 \Omega$ or less is recommended to ensure the stability of the ADP222/ ADP223/ADP224/ADP225. Transient response to changes in load current is also affected by output capacitance. Using a larger value of output capacitance improves the transient response of the ADP222/ADP223/ADP224/ADP225 to large changes in load current. Figure 65 shows the transient responses for an output capacitance value of $1 \mu \mathrm{~F}$.

## Input Bypass Capacitor

Connecting a $1 \mu \mathrm{~F}$ capacitor from VIN to GND reduces the circuit sensitivity to the printed circuit board (PCB) layout, especially when long input traces or high source impedance are encountered. If greater than $1 \mu \mathrm{~F}$ of output capacitance is required, the input capacitor should be increased to match it.

## Input and Output Capacitor Properties

Any good quality ceramic capacitors can be used with the ADP222/ADP223/ADP224/ADP225, as long as they meet the minimum capacitance and maximum ESR requirements. Ceramic capacitors are manufactured with a variety of dielectrics, each with different behavior over temperature and applied voltage. Capacitors must have a dielectric adequate to ensure the minimum capacitance over the necessary temperature range and dc bias conditions. X5R or X7R dielectrics with a voltage rating of 6.3 V or 10 V are recommended, but Y5V and Z5U dielectrics are not recommended, due to their poor temperature and dc bias characteristics.

Figure 66 depicts the capacitance vs. voltage bias characteristic of an $0402,1 \mu \mathrm{~F}, 10 \mathrm{~V}, \mathrm{X} 5 \mathrm{R}$ capacitor. The voltage stability of a capacitor is strongly influenced by the capacitor size and voltage rating. In general, a capacitor in a larger package or higher voltage rating exhibits better stability. The temperature variation of the X 5 R dielectric is $\sim \pm 15 \%$ over the $-40^{\circ} \mathrm{C}$ to $+85^{\circ} \mathrm{C}$ temperature range and is not a function of package or voltage rating.

Use Equation 1 to determine the worst-case capacitance accounting for capacitor variation over temperature, component tolerance, and voltage.

where:
$\mathrm{C}_{\text {BIAS }}$ is the effective capacitance at the operating voltage. TEMPCO is the worst-case capacitor temperature coefficient. TOL is the worst-case component tolerance.
In this example, the worst-case temperature coefficient (TEMPCO) over $-40^{\circ} \mathrm{C}$ to $+85^{\circ} \mathrm{C}$ is assumed to be $15 \%$ for an X 5 R dielectric. The tolerance of the capacitor (TOL) is assumed to be $10 \%$, and $\mathrm{C}_{\text {bias }}$ is $0.94 \mu \mathrm{~F}$ at 1.8 V , as shown in Figure 66.

Substituting these values in Equation 1 yields

C_{E F F}=0.94 \mu \mathrm{~F} \times(1-0.15) \times(1-0.1)=0.719 \mu \mathrm{~F}
$$

Therefore, the capacitor chosen in this example meets the minimum capacitance requirement of the LDO over temperature and tolerance at the chosen output voltage.
To guarantee the performance of the ADP222/ADP223/ ADP224/ADP225, it is imperative that the effects of dc bias, temperature, and tolerances on the behavior of the capacitors be evaluated for each application.

## ENABLE FEATURE

The ADP222/ADP223/ADP224/ADP225 use the ENx pins to enable and disable the VOUTx pins under normal operating conditions. Figure 67 shows a rising voltage on ENx crossing the active threshold, where Voutx turns on. When a falling voltage on ENx crosses the inactive threshold, Voutx turns off.

As shown in Figure 67, the ENx pins have built-in hysteresis. This prevents on/off oscillations that can occur due to noise on the ENx pins as it passes through the threshold points.

The active/inactive thresholds of the ENx pins are derived from the VIN voltage. Therefore, these thresholds vary with changing input voltage. Figure 68 shows typical ENx active/inactive thresholds when the input voltage varies from 2.5 V to 5.5 V .

The ADP222/ADP223/ADP224/ADP225 use an internal soft start to limit the inrush current when the output is enabled. The start-up time for the 2.8 V option is approximately $240 \mu \mathrm{~s}$ from the time the ENx active threshold is crossed to when the output reaches $90 \%$ of its final value. The start-up time is somewhat dependent on the output voltage setting and increases slightly as the output voltage increases.

## QUICK OUTPUT DISCHARGE (QOD) FUNCTION

The ADP224/ADP225 include an output discharge resistor to force the voltage on each output to zero when the respective LDO is disabled. This ensures that the outputs of the LDOs are always in a well-defined state, regardless if it is enabled or not. The ADP222/ADP223 do not include the output discharge function. Figure 70 compares the turn-off time of a 3.3 V output LDO with and without the QOD function. Both LDOs have a $1 \mathrm{k} \Omega$ resistor connected to each output. The LDO with the QOD function discharges the output to 0 V in less than 1 ms , whereas the $1 \mathrm{k} \Omega$ load takes over 5 ms to do the same.

## CURRENT LIMIT AND THERMAL OVERLOAD PROTECTION

The ADP222/ADP223/ADP224/ADP225 are protected against damage due to excessive power dissipation by current and thermal overload protection circuits. The ADP222/ADP223/ ADP224/ADP225 are designed to current limit when the output load reaches 300 mA (typical). When the output load exceeds 300 mA , the output voltage is reduced to maintain a constant current limit.
Thermal overload protection is included, which limits the junction temperature to a maximum of $155^{\circ} \mathrm{C}$ (typical). Under extreme conditions (that is, high ambient temperature and power dissipation) when the junction temperature starts to rise above $155^{\circ} \mathrm{C}$, the output is turned off, reducing the output current to 0 . When the junction temperature drops below $140^{\circ} \mathrm{C}$, the output is turned on again, and output current is restored to its nominal value.

Consider the case where a hard short from VOUTx to ground occurs. At first, the ADP222/ADP223/ADP224/ADP225 current limits, so that only 300 mA is conducted into the short. If self-heating of the junction is great enough to cause its temperature to rise above $155^{\circ} \mathrm{C}$, thermal shutdown activates, turning off the output and reducing the output current to 0 mA . As the junction temperature cools and drops below $140^{\circ} \mathrm{C}$, the output turns on and conducts 300 mA into the short, again causing the junction temperature to rise above $155^{\circ} \mathrm{C}$. This thermal oscillation between $140^{\circ} \mathrm{C}$ and $155^{\circ} \mathrm{C}$ causes a current oscillation between 300 mA and 0 mA that continues as long as the short remains at the output.
Current and thermal limit protections are intended to protect the device against accidental overload conditions. For reliable operation, device power dissipation must be externally limited so that junction temperatures do not exceed $125^{\circ} \mathrm{C}$.

## THERMAL CONSIDERATIONS

In most applications, the ADP222/ADP223/ADP224/ADP225 do not dissipate much heat due to its high efficiency. However, in applications with high ambient temperature, and high supply voltage to output voltage differential, the heat dissipated in the package is large enough that it can cause the junction temperature of the die to exceed the maximum junction temperature of $125^{\circ} \mathrm{C}$.
When the junction temperature exceeds $155^{\circ} \mathrm{C}$, the converter enters thermal shutdown. It recovers only after the junction temperature has decreased below $140^{\circ} \mathrm{C}$ to prevent any permanent damage. Therefore, thermal analysis for the chosen application is very important to guarantee reliable performance over all conditions. The junction temperature of the die is the sum of the ambient temperature of the environment and the temperature rise of the package due to the power dissipation, as shown in Equation 2.

To guarantee reliable operation, the junction temperature of the ADP222/ADP223/ADP224/ADP225 must not exceed $125^{\circ} \mathrm{C}$. To ensure that the junction temperature stays below this maximum value, the user must be aware of the parameters that contribute to junction temperature changes. These parameters include ambient temperature, power dissipation in the power device, and thermal resistances between the junction and ambient air $\left(\theta_{\text {IA }}\right)$. The $\theta_{\text {JA }}$ number is dependent on the package assembly compounds that are used and the amount of copper used to solder the package GND pin to the PCB.

Table 6 shows typical $\theta_{J A}$ values of the 8 -lead LFCSP package for various PCB copper sizes, and Table 7 shows the typical $\Psi^{\text {IB }}$ value of the 8-lead LFCSP.

$V_{\text {IN }}$ and $V_{\text {OUT }}$ are input and output voltages, respectively.
Power dissipation due to ground current is quite small and can be ignored. Therefore, the junction temperature equation simplifies to the following:

T_{J}=T_{A}+\left\{\left[\left(V_{I N}-V_{\text {OUT }}\right) \times I_{\text {LOAD }}\right] \times \theta_{I A}\right\}

As shown in the simplified equation, for a given ambient temperature, input- to-output voltage differential, and continuous load current, there exists a minimum copper size requirement for the PCB to ensure that the junction temperature does not rise above $125^{\circ} \mathrm{C}$. In the case where the board temperature is known, use the thermal characterization parameter, $\Psi_{J B}$, to estimate the junction temperature rise (see Figure 74). Maximum junction temperature $\left(\mathrm{T}_{\mathrm{J}}\right)$ is calculated from the board temperature $\left(\mathrm{T}_{\mathrm{B}}\right)$ and power dissipation $\left(\mathrm{P}_{\mathrm{D}}\right)$ using the following formula:

T_{J}=T_{B}+\left(P_{D} \times \Psi_{J B}\right) \tag{3}
\end{equation*}
$$

The typical value of $\Psi_{J B}$ is $18.2^{\circ} \mathrm{C} / \mathrm{W}$ for the 8-lead LFCSP package.

## PRINTED CIRCUIT BOARD LAYOUT CONSIDERATIONS

Heat dissipation from the package can be improved by increasing the amount of copper attached to the pins of the ADP222/ADP223/ADP224/ADP225. However, as listed in Table 6, a point of diminishing returns is eventually reached beyond which an increase in the copper size does not yield significant heat dissipation benefits.
Place the input capacitor as close as possible to the VIN and GND pins. Place the output capacitor as close as possible to the VOUTx and GND pins. Use of 0402 or 0603 size capacitors and resistors achieves the smallest possible footprint solution on boards where area is limited.
