




Fig 1. Diode capacitance as a function of reverse voltage; typical values

f = 1 MHz; $T_i = 25 \, ^{\circ}\text{C}$.




f = 100 MHz; $T_i = 25 \, ^{\circ}\text{C}$.




Fig 5. Package outline SOD323
