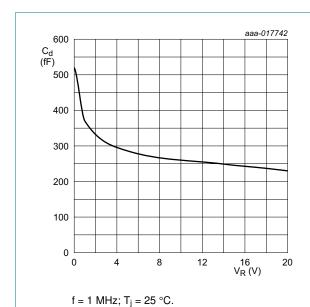




Fig 1. Diode capacitance as a function of reverse voltage; typical values

Fig 2. Forward resistance as a function of forward current; typical values






Fig 5. Package outline SOT23
