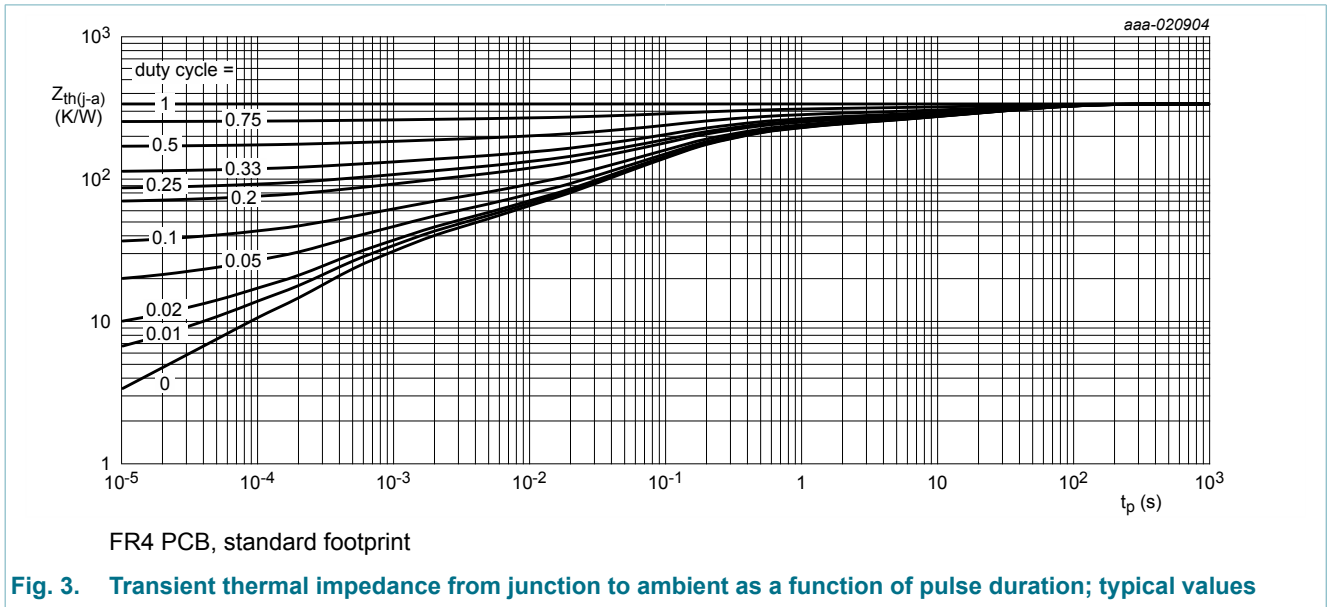

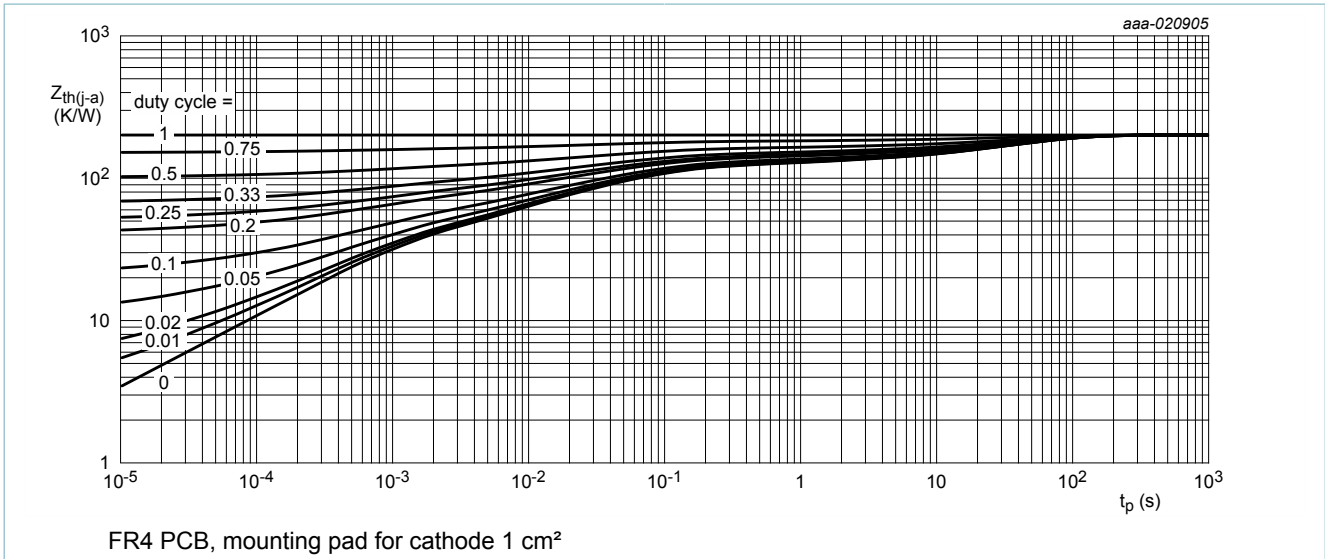
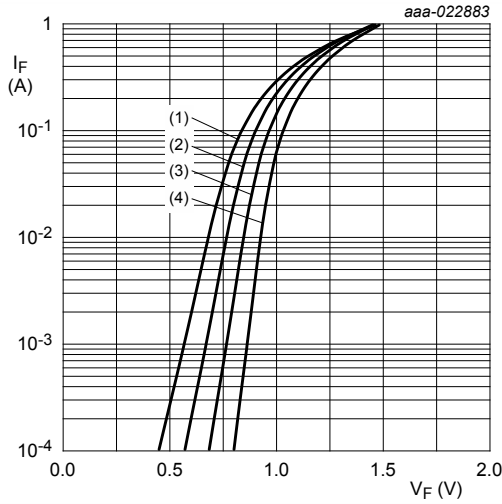


Fig. 4. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

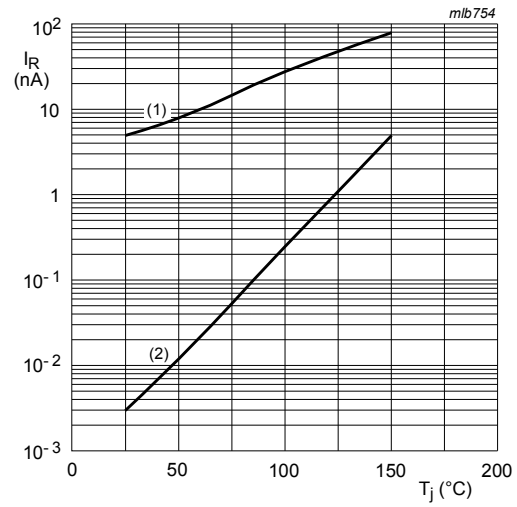

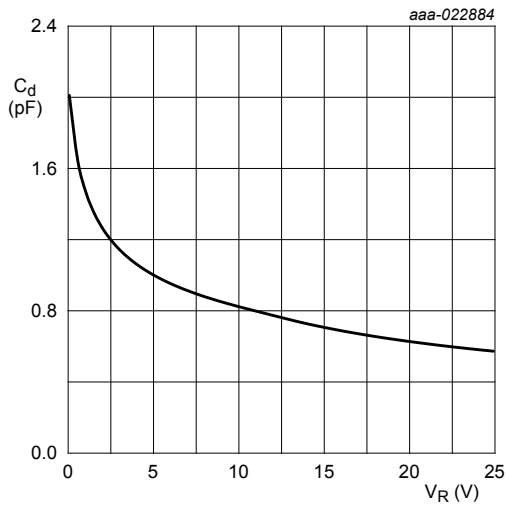

Fig. 5. Forward current as a function of forward voltage; typical values



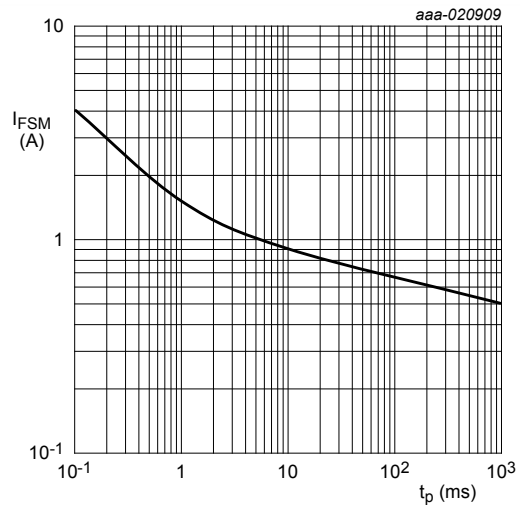

$f = 1\text{ MHz}$ ;  $T_{\text{amb}} = 25^\circ\text{C}$

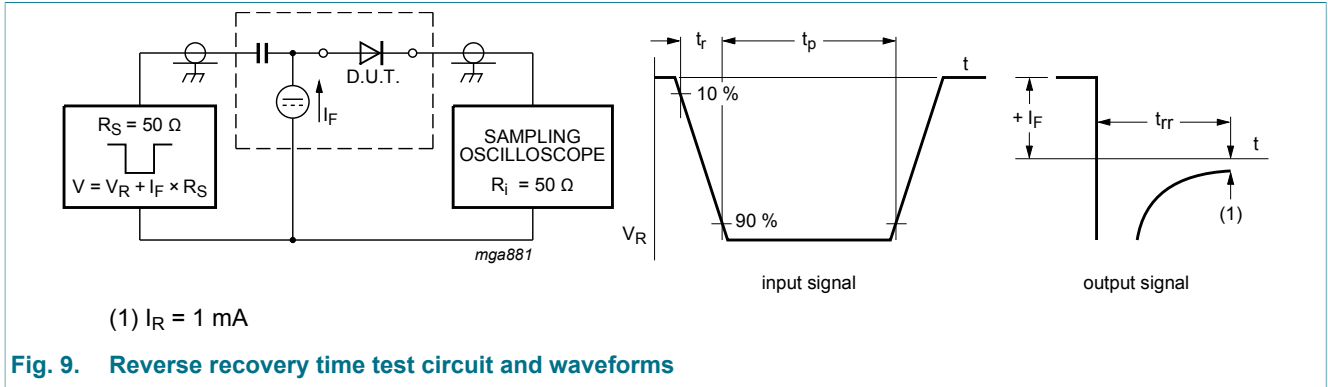
Fig. 7. Diode capacitance as a function of reverse voltage; typical values

Fig. 8. Non-repetitive forward current as a function of pulse duration; maximum values

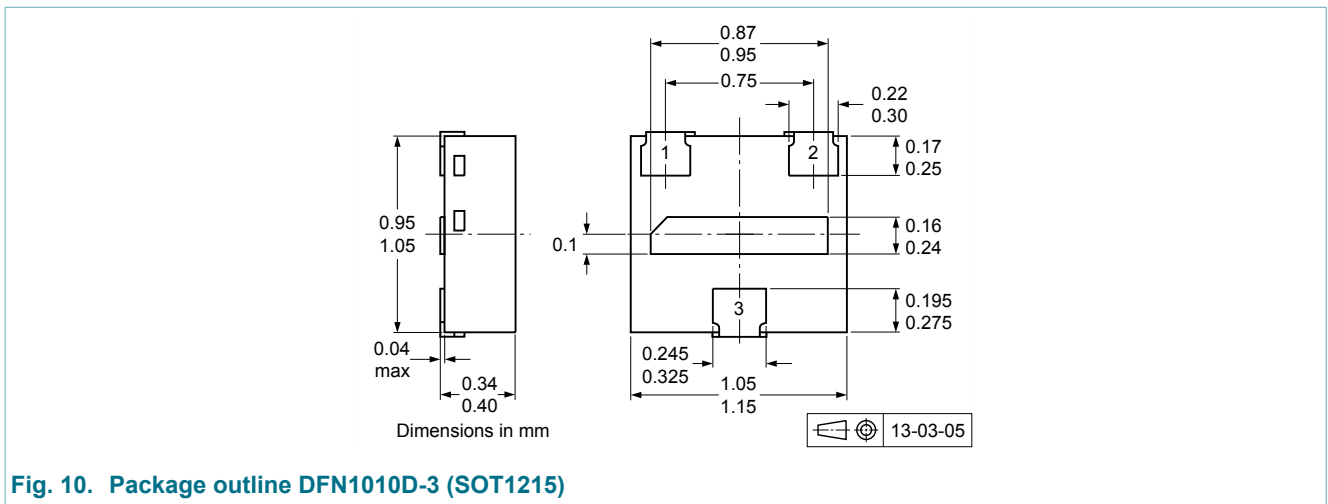

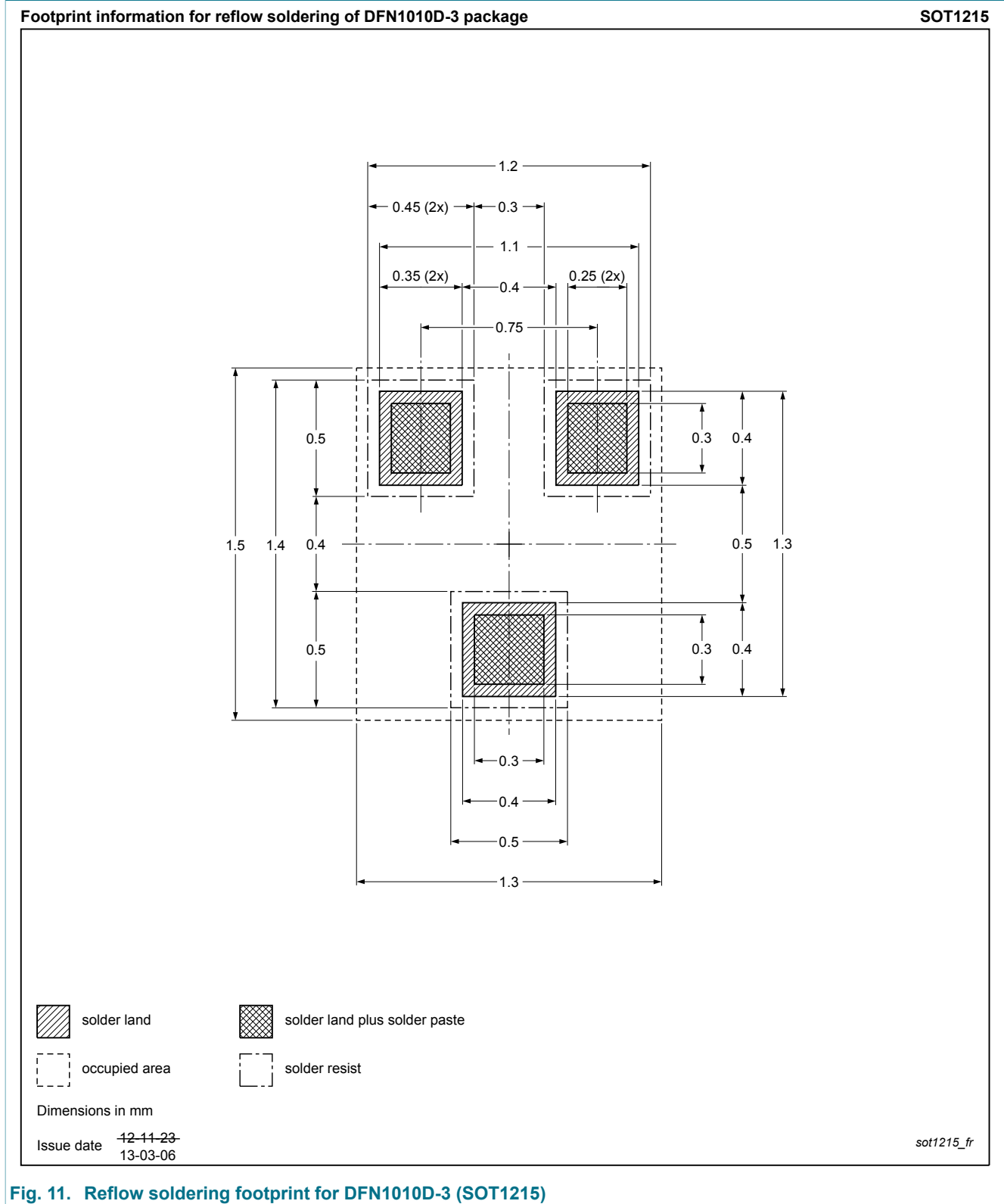


Fig. 11. Reflow soldering footprint for DFN1010D-3 (SOT1215)
