




Diode capacitance $C_T = f(V_R)$

f = 1MHz




Normalized diode capacitance

 $C_{(TA)}/C_{(25^{\circ}C)} = f(T_A); f = 1MHz$ $V_R = Parameter$




Temperature coefficient of the diode capacitance $T_{Cc} = f(V_R)$



Reverse current $I_R = f(T_A)$



Reverse current $I_R = f(V_R)$








