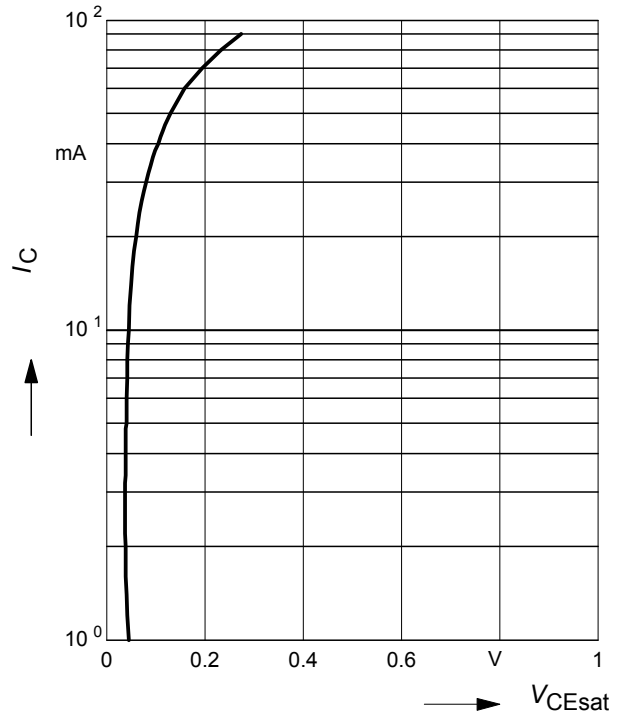

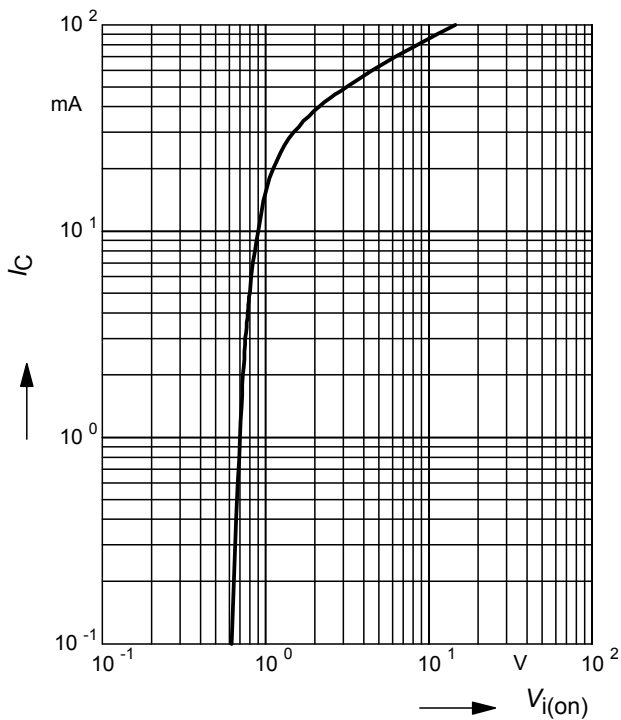

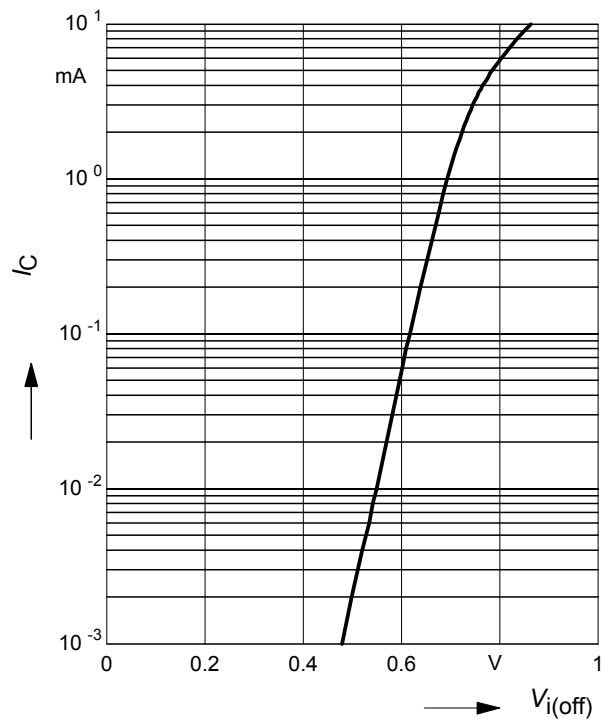

Permissible Pulse Load $R_{thJS} = f(t_p)$

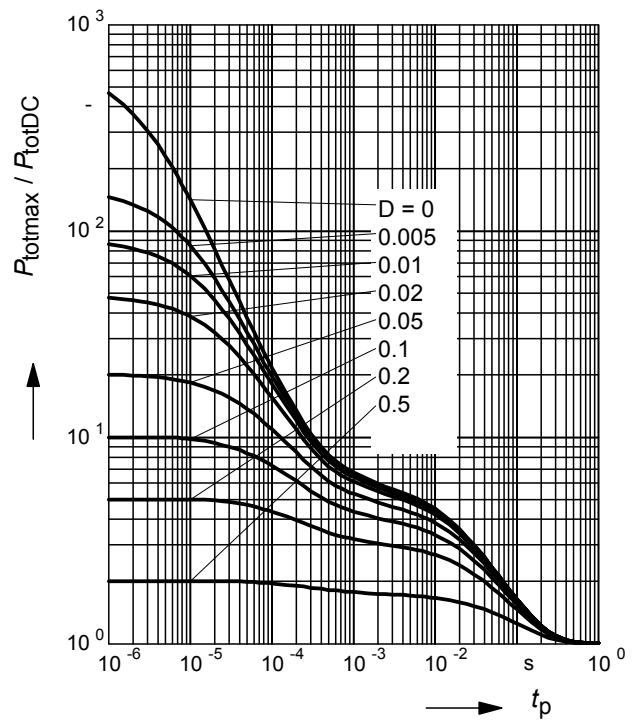

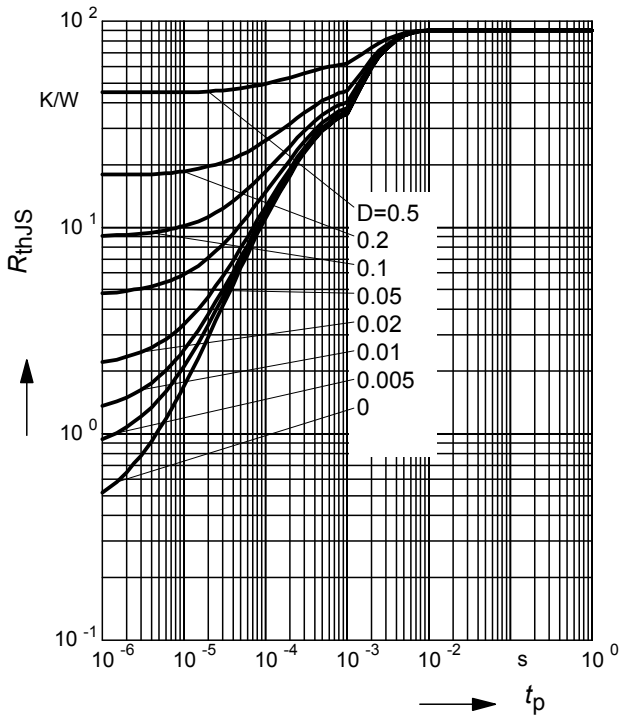

Permissible Puls Load $R_{thJS} = f(t_p)$

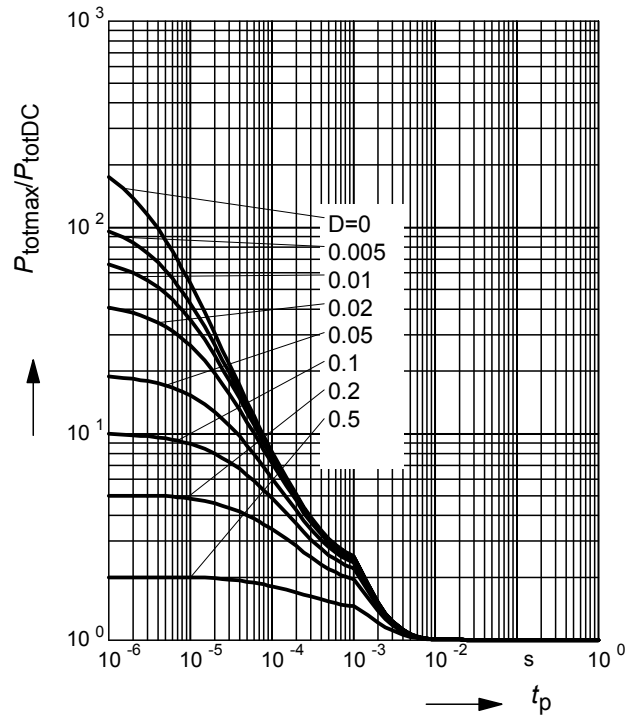

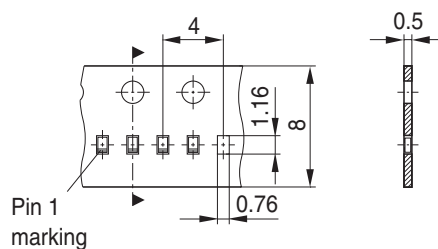
