












Fig 5. Power gain and drain efficiency as function of output power; typical values

Fig 6. Adjacent channel power ratio (5MHz) as a function of output power; typical values



Fig 7. Peak-to-average power ratio as a function of output power; typical values






Fig 10. Package outline SOT502B
