




Fig. 1 Typical Trigger Delay Time




Fig. 4 Pulse Trigger Current




Fig. 2 Power Dissipation 40 to 60 Hz Line Operation




Fig. 5 Typical Input Characteristics




Fig. 3 Typical Off-State Current






Fig. 6 Typical Output Characteristics












Fig. 8 Current Reduction
