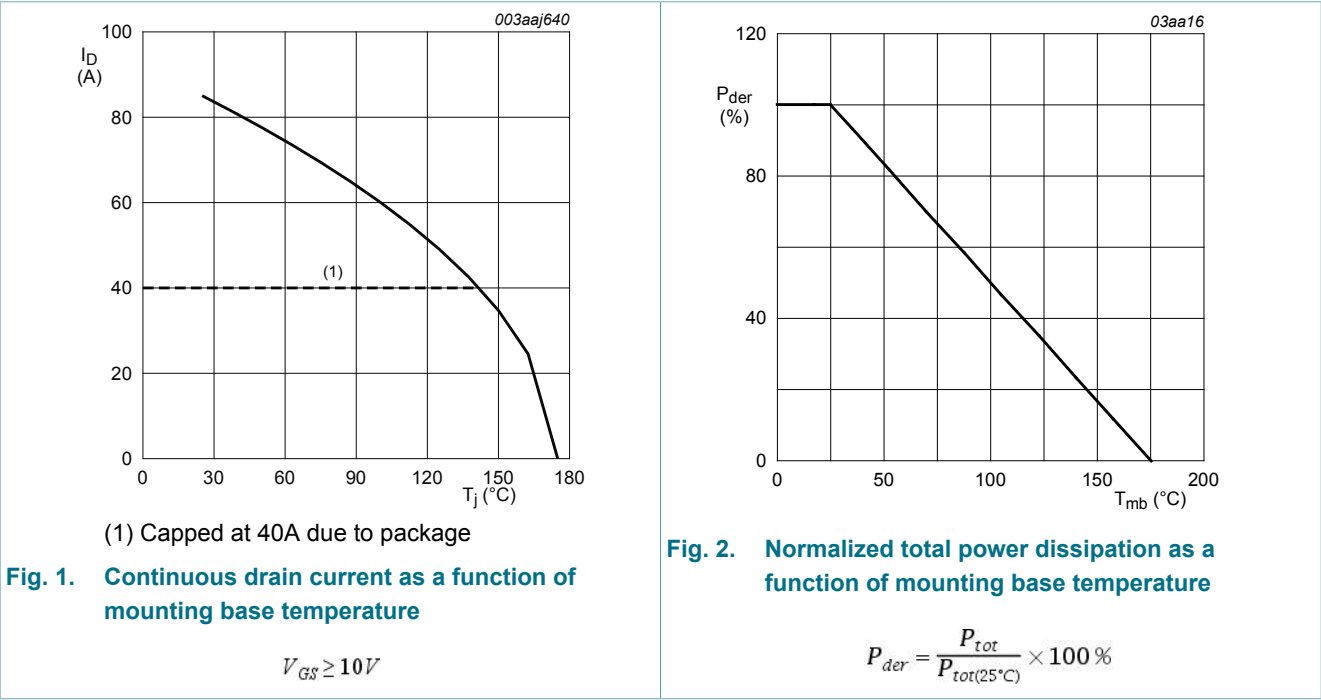

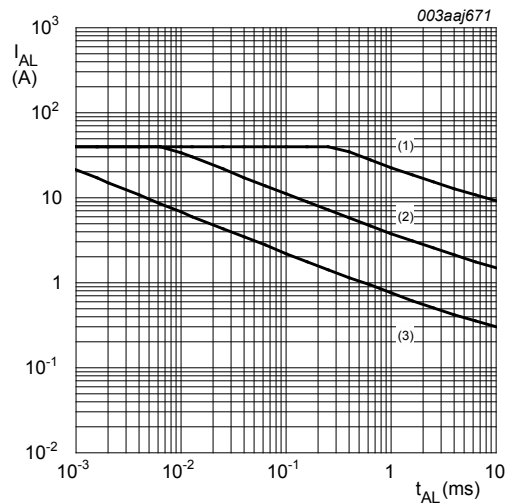


Fig. 3. Single-pulse and repetitive avalanche rating; avalanche current as a function of avalanche time, FET1 and FET2

- (3) Repetitive.

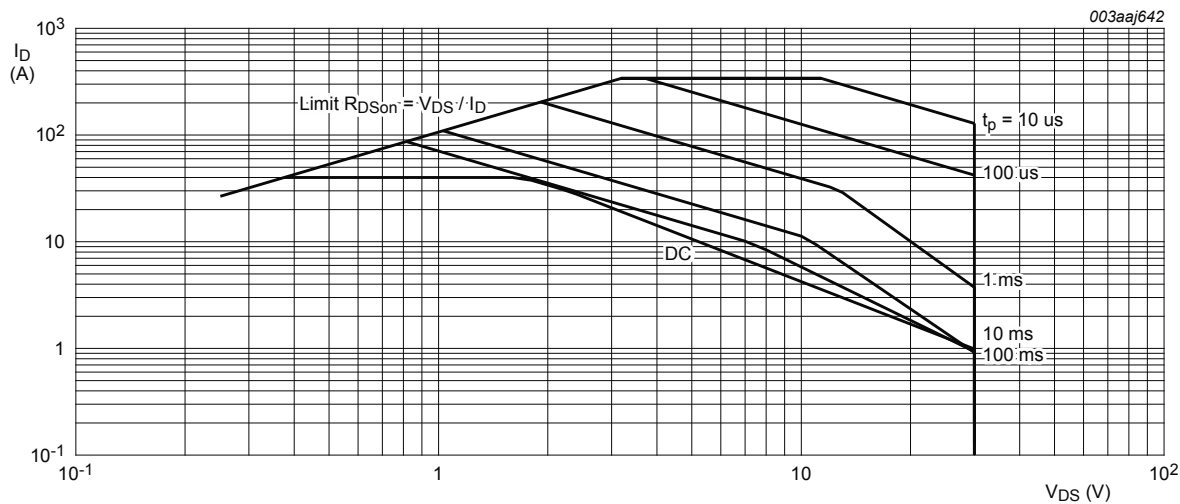


Fig. 4. Safe operating area; continuous and peak drain current as a function of drain-source voltage

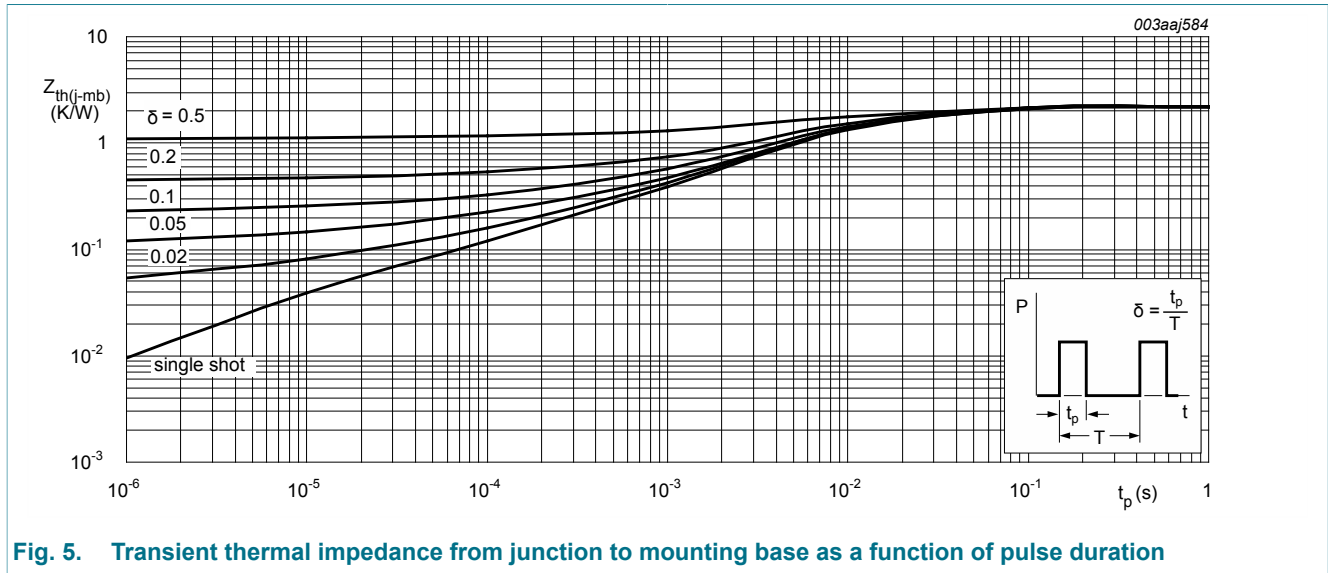


Fig. 5. Transient thermal impedance from junction to mounting base as a function of pulse duration

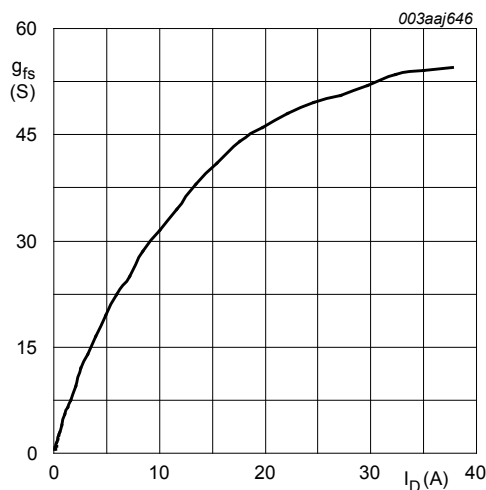


Fig. 6. Forward transconductance as a function of drain current; typical values

$$T_J = 25^\circ\text{C}; V_{DS} = 10\text{ V}$$

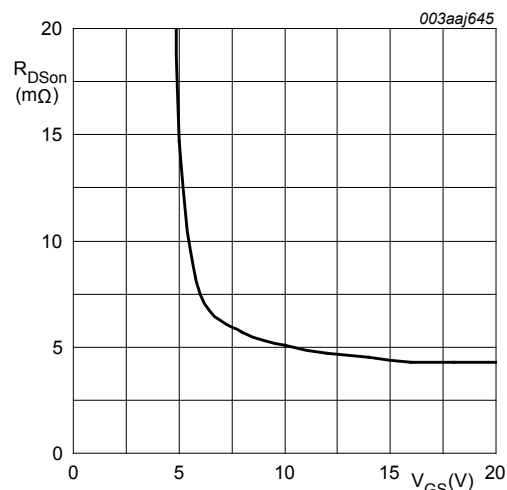


Fig. 7. Drain-source on-state resistance as a function of gate-source voltage; typical values

$$T_J = 25^\circ\text{C}; I_D = 10\text{ A}$$

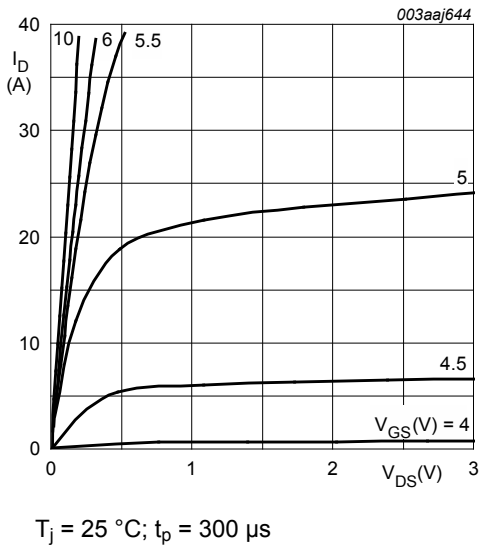


Fig. 8. Output characteristics; drain current as a function of drain-source voltage; typical values

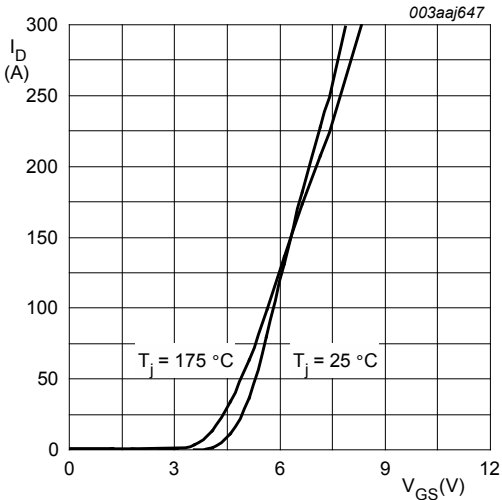


Fig. 9. Transfer characteristics: drain current as a function of gate-source voltage; typical values

$V_{DS} = 10\text{ V}$

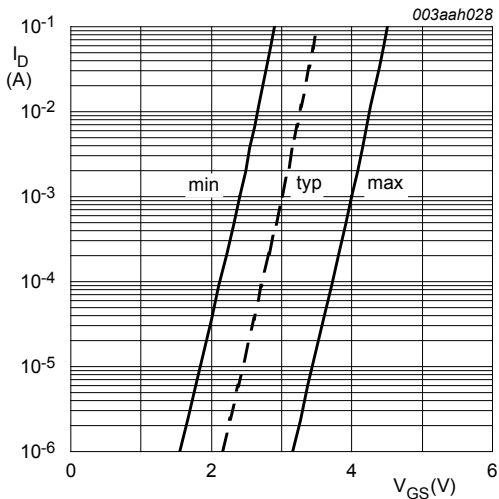


Fig. 10. Sub-threshold drain current as a function of gate-source voltage

$T_j = 25^\circ\text{C}; V_{DS} = 5\text{ V}$

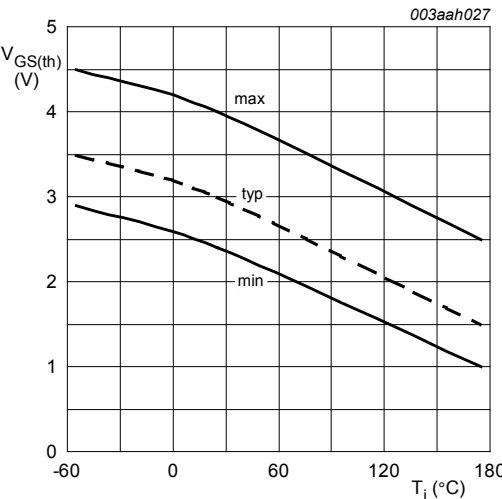


Fig. 11. Gate-source threshold voltage as a function of junction temperature

$I_D = 1\text{ mA}; V_{DS} = V_{GS}$

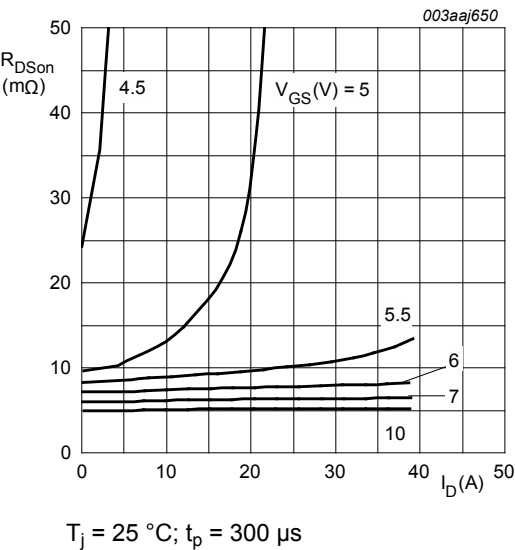


Fig. 12. Drain-source on-state resistance as a function of drain current; typical values

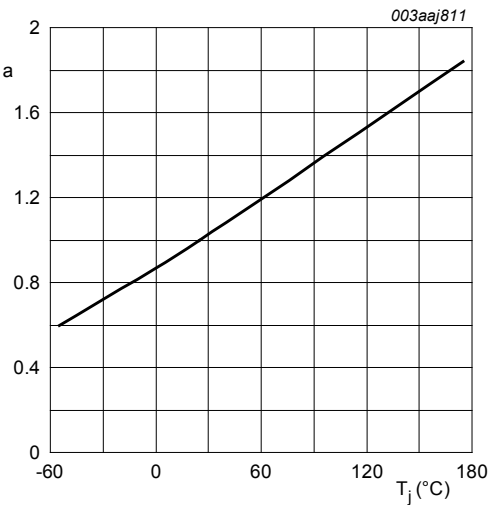


Fig. 13. Normalized drain-source on-state resistance factor as a function of junction temperature

$$a = \frac{R_{DSon}}{R_{DSon}(25^\circ\text{C})}$$

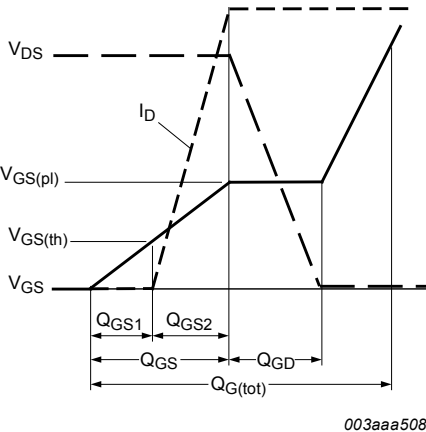


Fig. 14. Gate charge waveform definitions

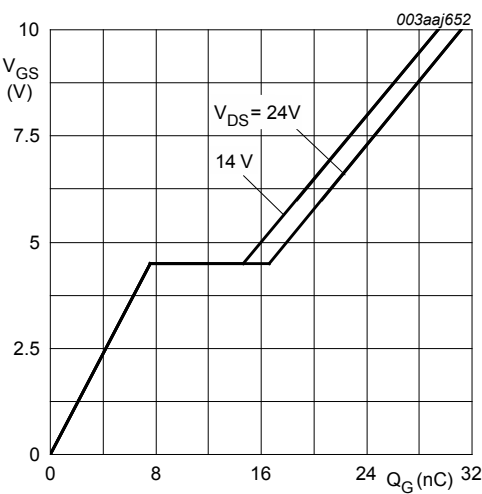


Fig. 15. Gate-source voltage as a function of gate charge; typical values

$$T_J = 25^\circ\text{C}; I_D = 10\text{A}$$

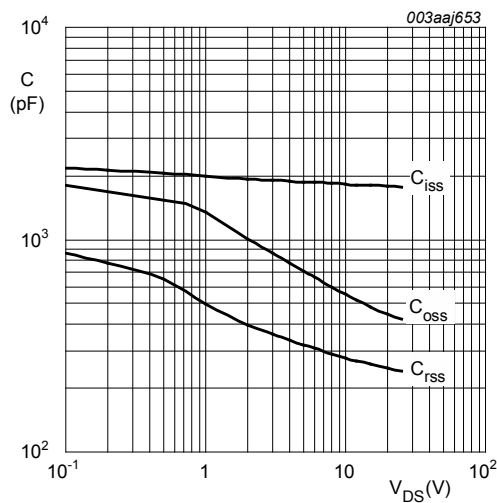


Fig. 16. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values

$V_{GS}=0V; f=1MHz$

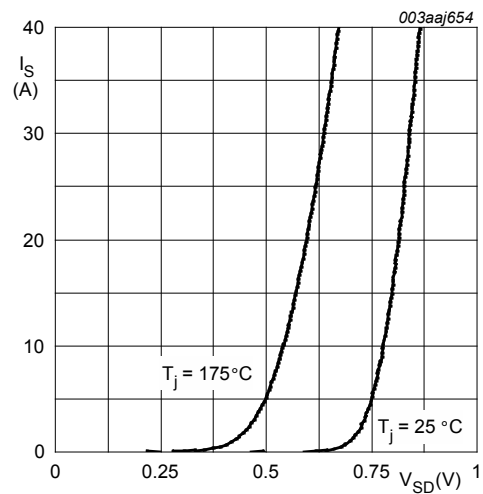


Fig. 17. Source (diode forward) current as a function of source-drain (diode forward) voltage; typical values

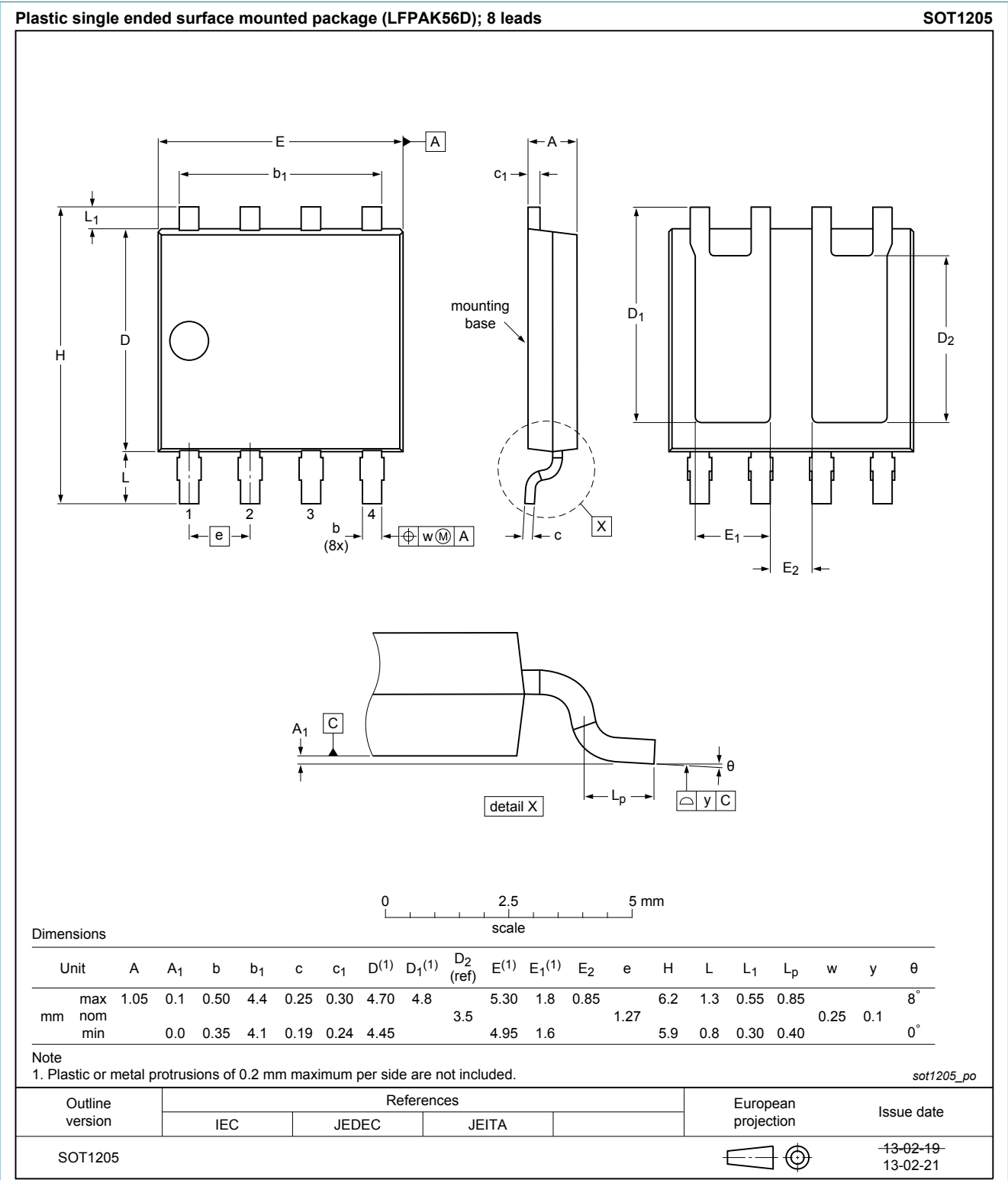


Fig. 18. Package outline LPAK56D (SOT1205)
