



Internal Schematic







Typical Characteristics - N-CHANNEL
















Figure 8 Gate Threshold Variation vs. Ambient Temperature








Typical Characteristics - P-CHANNEL
















Figure 19 Gate Threshold Variation vs. Ambient Temperature


