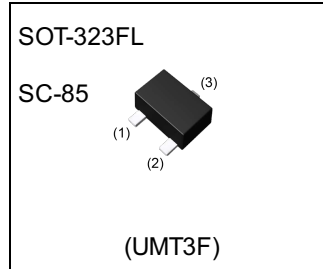

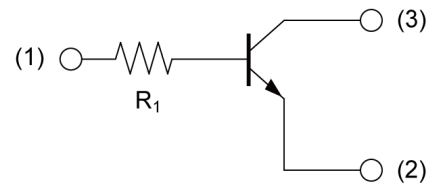

Fig.1 Grounded emitter propagation characteristics

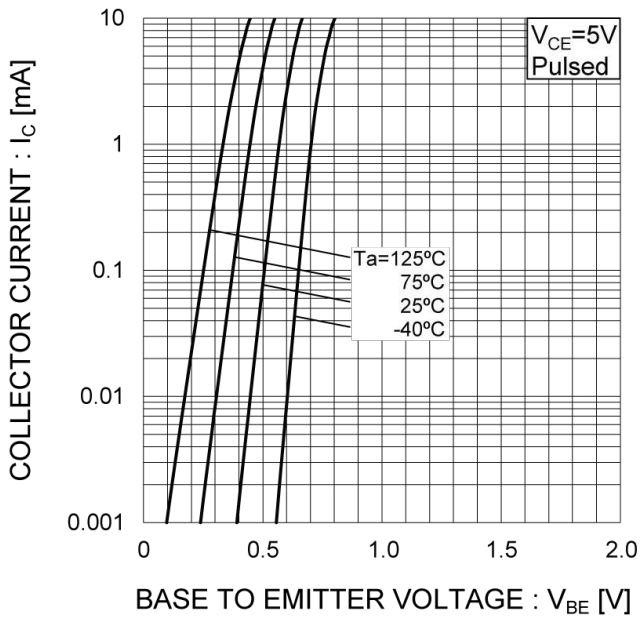


Fig.2 Grounded emitter output characteristics

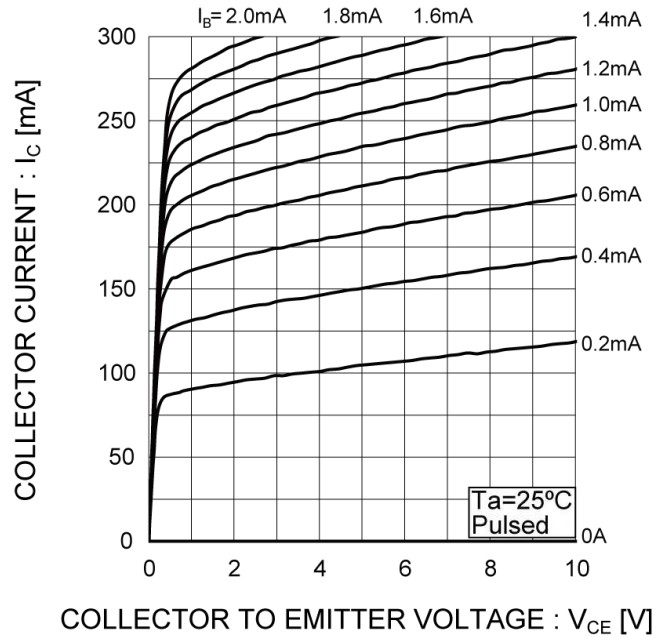


Fig.3 DC Current gain vs. Collector Current

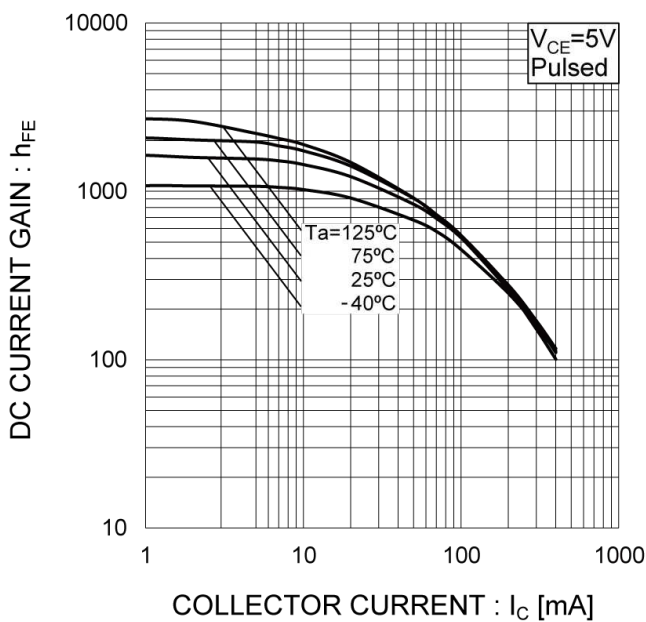
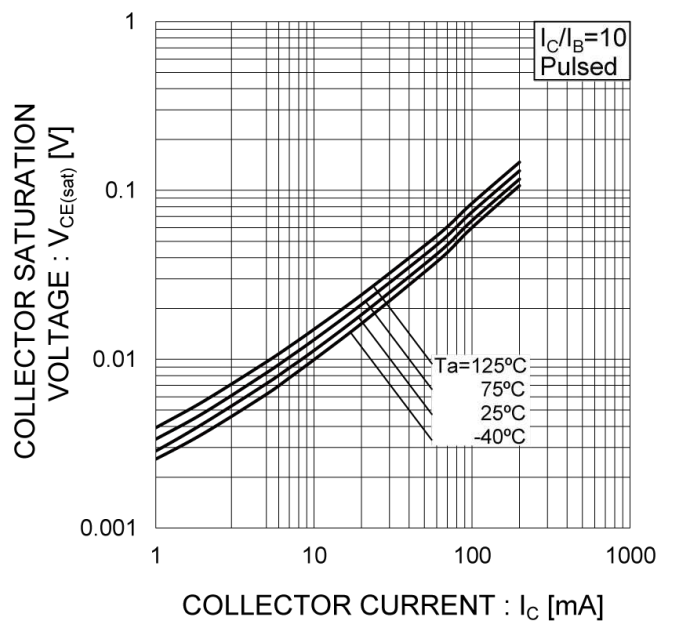
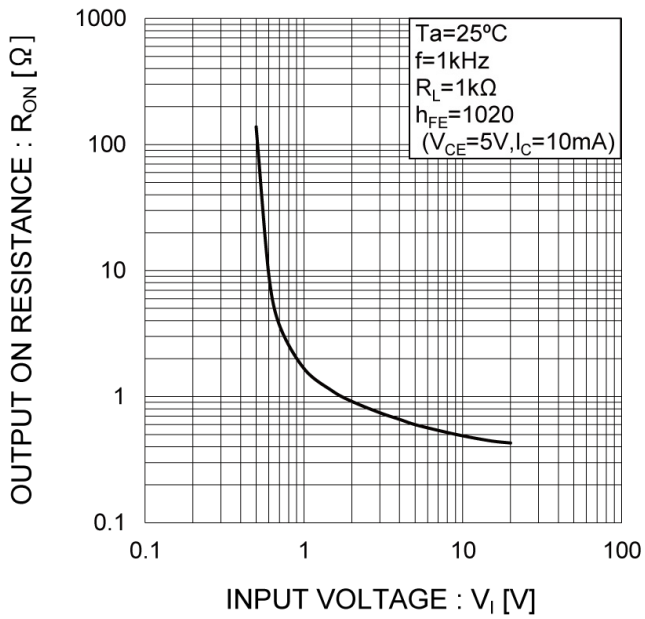


Fig.4 Collector-emitter saturation voltage vs. Collector Current

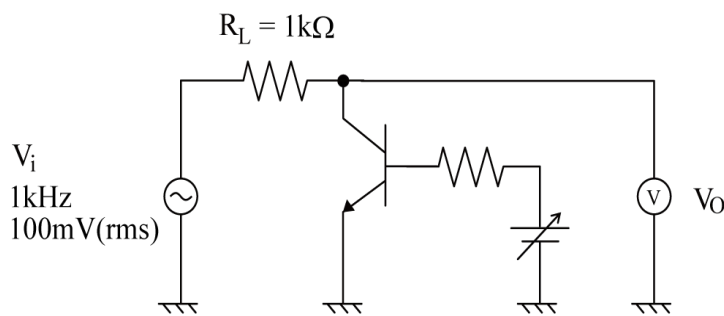


● Electrical characteristic curves (T<sub>a</sub> = 25°C)

Fig.5 Output ON resistance vs. input voltage

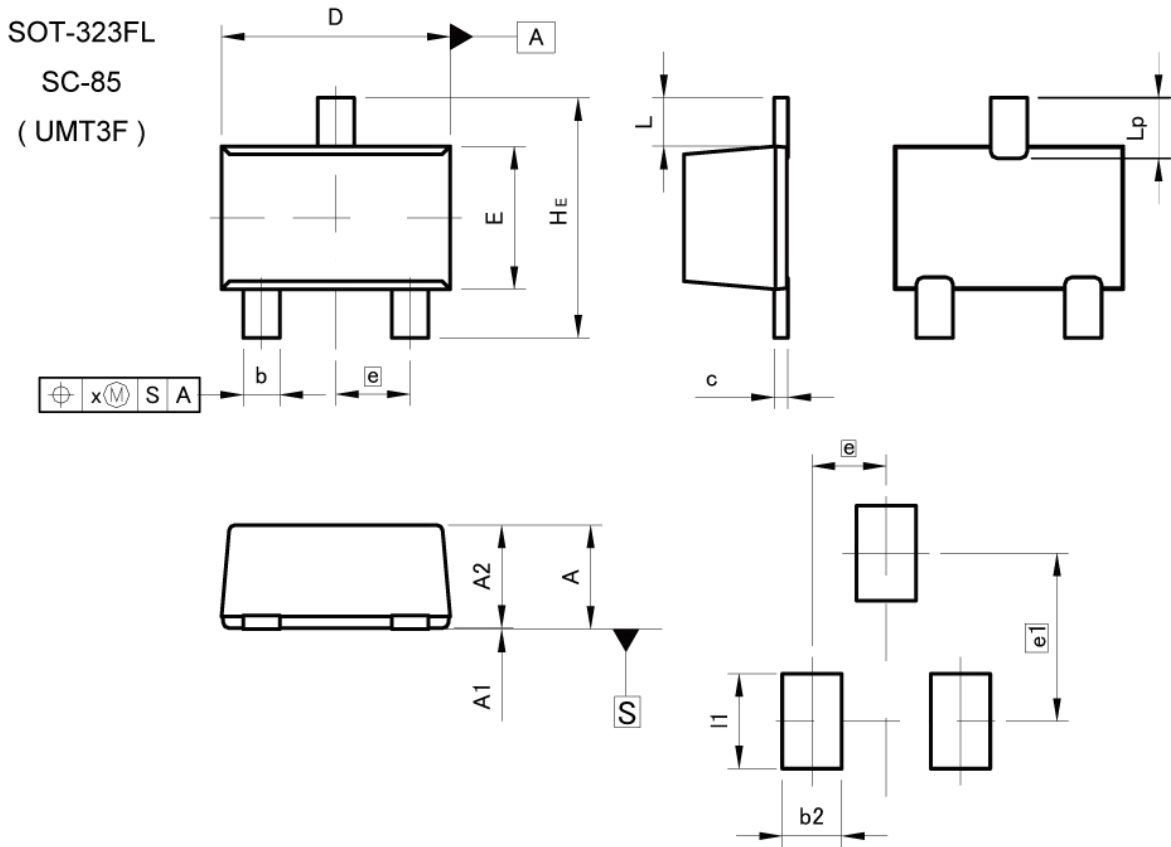


R<sub>on</sub> MEASUREMENT CIRCUIT
