




Figure 1. DC Current Gain




Figure 3. Input-Off Voltage




Figure 2. Input-On Voltage




Figure 4. Power Derating




Figure 5. 3-LEAD, SC89, EIAJ-SC89, 0.88 MM WIDE, SOT523F (ACTIVE)
