




Figure 1. SC70 Pin Assignments (Top View)

Figure 2. MicroPak™ Pin Assignments (Top View)




Figure 3. MicroPak2™ Pin Assignments (Top View)





Figure 5. Off Leakage






Figure 6. On Leakage

Figure 7. Test Circuit Load





Figure 8. Turn-On / Turn-Off Waveforms

Figure 10. Channel Off Isolation




Figure 11. Charge Injection Test




Figure 12. Channel Off Capacitance




Figure 13. Channel On Capacitance




Figure 14. 6-Lead, SC70, EIAJ SC-88a, 1.25mm Wide






Figure 16. 6-Lead, MicroPak2, 1x1mm Body, .35mm Pitch
