


Figure 1. KA278R33 / 05 / 12C




Figure 3. Output Voltage vs. Input Voltage




Figure 4. Quiescent Current vs. Input Voltage




Figure 5. Output Voltage vs. Disable Voltage




Figure 6. Output Voltage vs. Temperature (T<sub>i</sub>)




Figure 7. Quiescent Current vs. Temperature  $(T_j)$ 





Figure 8. Dropout Voltage vs. Junction Temperature






Figure 9. Power Dissipation vs. Temperature  $(T_j)$ 

Figure 10. Over-Current Protection Characteristics (Typical Value)




Figure 11. Output Peak Current vs. Input-Output




Figure 12. Output Voltage vs. Input Voltage




Figure 13. Quiescent Current vs. Input Voltage




Figure 14. Output Voltage vs. Disable Voltage




Figure 15. Output Voltage vs. Temperature (T<sub>i</sub>)




figure 16. Quiescent Current vs. Temperature (T<sub>i</sub>)





Figure 17. Dropout Voltage vs. Junction Temperature






Figure 18. Power Dissipation vs. Temperature  $(T_j)$ 

Figure 19. Over-Current Protection Characteristics (Typical Value)




Figure 20. Output Peak Current vs. Input-Output




Figure 21. Output Voltage vs. Input Voltage




Figure 22. Quiescent Current vs. Input Voltage




Figure 23. Output Voltage vs. Disable Voltage





Figure 24. Output Voltage vs. Temperature (T<sub>i</sub>)



25. Quiescent Current vs. Temperature (T<sub>i</sub>)





Figure 26. Dropout Voltage vs. Junction Temperature






Figure 27. Power Dissipation vs. Temperature  $(T_j)$ 

Figure 28. Over-Current Protection Characteristics (Typical Value)




Figure 29. Output Peak Current vs. Input-Output




Figure 30. Output Voltage vs. Input Voltage




Figure 31. Quiescent Current vs. Input Voltage




Figure 32. Output Voltage vs. Temperature  $(T_j)$ \*Fixed Mode  $(V_O = 5 V)$ 




Figure 33. Quiescent Current vs. Temperature (T<sub>j</sub>)




Figure 34. Dropout Voltage vs. Junction Temperature





Figure 35. Power Dissipation vs. Temperature  $(T_j)$ 






Figure 36. Over-Current Protection Characteristics (Typical Value)




Figure 38. Application Circuit




Figure 39. Application Circuit (Adjustable Mode)




Figure 40. Internal Resistor (R<sub>1</sub>, R<sub>2</sub>) Variation vs. Temperature (T<sub>j</sub>)




Figure 41. Application Circuit (Fixed Mode)




Figure 42. TO220, MOLDED, 4-LEAD, FULL-PACK, STARIGHT LEAD (ACTIVE)




