


The MB2198-502 header board was built for the FPT-100P-M20 (LQFP) package to connect the MB2198-500 with the target-system.

Related documents such as MB96300 Series Hardware Manual are available and should always be use in addition to this manual.

2 Installation

- Remove carefully the board from the shipping carton.
- Check first if there are any damages.
- Check the contents of the box.
 - 1x MB2198-502
 - 1x YQ-PACK100SD
 - 1x NQ-PACK100SD-ND
 - 1x HQ-PACK100SD
 - 1x User guide 960005-10
- Press **carefully and smooth** the YQ-PACK100SD or the QFP-EXTENDER-100SD in the YQ-SOCKET100SND
- Remove MCU out of the socket (NQ-PACK) before using the header board

The connection between YQ-SOCKET100SND and YQ-PACK100SD or QFP-EXTENDER-100SD is only once pluggable, since otherwise the pins can break off.
