


Figure 1. DC Current Gain




Figure 2. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage




Figure 3. Collector Capacitance




Figure 4. Turn-On Time




Figure 5. Turn-Off Time




Figure 6. Safe Operating Area





Figure 7. Power Derating




Figure 8. TO-251 (IPAK) MOLDED, 3-LEAD (ACTIVE)
