



Figure 1. Simplified Logic Diagram




Figure 2. Pin Connections (Top View)




Figure 3. Typical Phase Noise Plot at 125 MHz




Figure 4. Typical Phase Noise Plot at 250 MHz




Figure 5. Typical Termination for Output Driver and Device Evaluation (See Application Note AND8020/D – Termination of ECL Logic Devices.)





Figure 6. Recommended Reflow Soldering Profile


