




Fig 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values





Fig 4. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

Fig 5. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values







DC current gain as a function of collector Fig 6. current; typical values




Collector current as a function of Fig 7. collector-emitter voltage; typical values


Fig 8. Base-emitter voltage as a function of collector current; typical values

Fig 9. Base-emitter saturation voltage as a function of collector current; typical values





Fig 10. Collector-emitter saturation voltage as a function of collector current; typical values



Fig 11. Collector-emitter saturation voltage as a function of collector current; typical values








Fig 14. BISS transistor switching time definition





Fig 15. Test circuit for switching times


