

Method of Diagram 2: Non breakdown test (Apply to all device test)



 - Tape structure and Dimensions (Refer to the attached sheet, Page 11) The carrier tape has the heat pressed structure of PS material carries tape and three layers cover tape (PET material base).
 - (2) Reel structure and Dimensions (Refer to the attached sheet, Page 12) The taping reel shall be of plastic (PS material).

Carrier tape structure and Dimensions







Outer packing appearance




Precautions for Photocouplers

1 Cleaning

- (1) Solvent cleaning : Solvent temperature 45° C or less
 - Immersion for 3 min or less
- (2) Ultrasonic cleaning : The effect to device by ultrasonic cleaning differs by cleaning bath size, ultrasonic power output, cleaning time, PCB size or device mounting condition etc. Please test it in actual using condition and confirm that any defect doesn't occur before starting the ultrasonic cleaning.
- (3) Applicable solvent : Ethyl alcohol, Methyl alcohol, Isopropyl alcohol
 When the other solvent is used, there are cases that the packaging resin is eroded.
 Please use the other solvent after thorough confirmation is performed in actual using condition.
- 2. Circuit design
 - The LED used in the Photocoupler generally decreases the light emission power by operation. In case of long operation time, please design the circuit in consideration of the degradation of the light emission power of the LED. (50%/5years)
 - (2) There are cases that the deviation of the CTR and the degradation of the relative light emission power of the LED increase when the setting value of I_{ir} is less than 1.0mA. Please design the circuit in consideration of this point.
