






NORMALIZED ON-STATE RESISTANCE vs. AMBIENT TEMPERATURE




#### TURN-ON TIME vs. FORWARD CURRENT




#### TURN-ON TIME DISTRIBUTION









#### TURN-OFF TIME vs. FORWARD CURRENT




#### TURN-OFF TIME DISTRIBUTION




