








OFF-STATE LEAKAGE CURRENT vs. APPLIED VOLTAGE









# OUTPUT CAPACITANCE vs. APPLIED VOLTAGE




### LORD CURRENT vs. LORD VOLTAGE




# NORMALIZED ON-STATE RESISTANCE vs. AMBIENT TEMPERATURE




#### **ON-STATE RESISTANCE DISTRIBUTION**




#### TURN-ON TIME vs. FORWARD CURRENT




#### TURN-OFF TIME vs. FORWARD CURRENT



#### TURN-ON TIME DISTRIBUTION




TURN-OFF TIME DISTRIBUTION





# NORMALIZED TURN-ON TIME vs. AMBIENT TEMPERATURE




