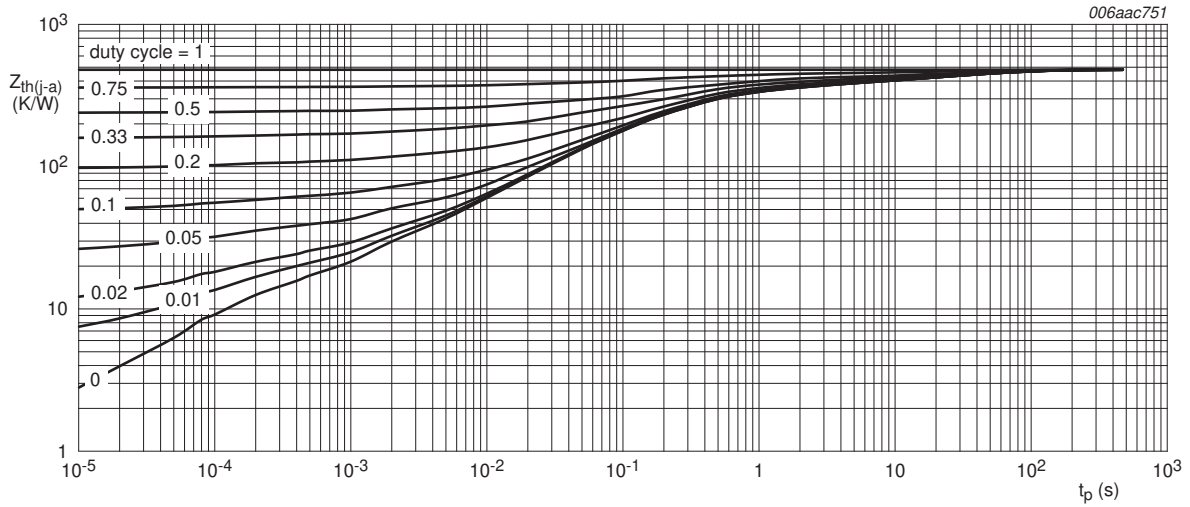

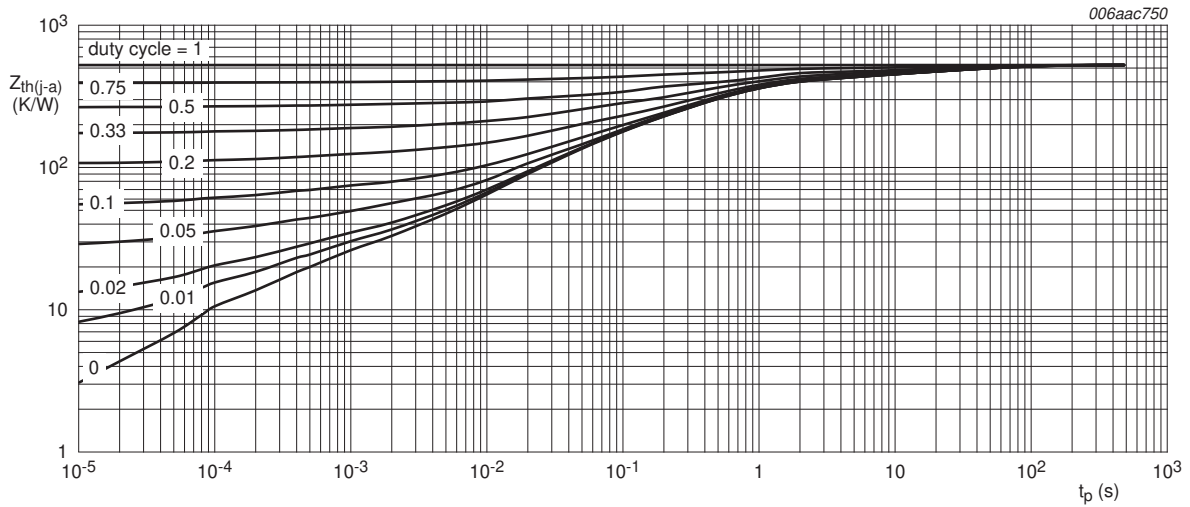

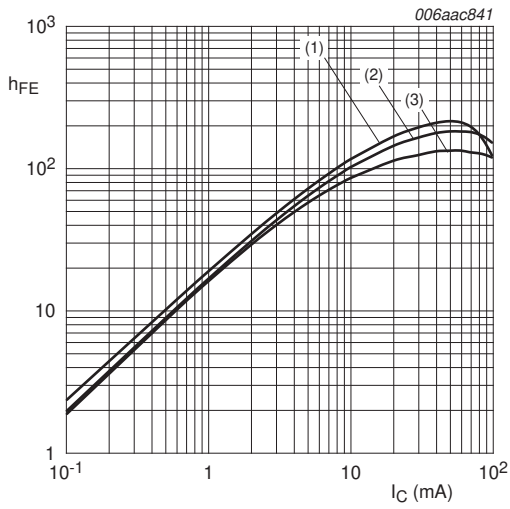

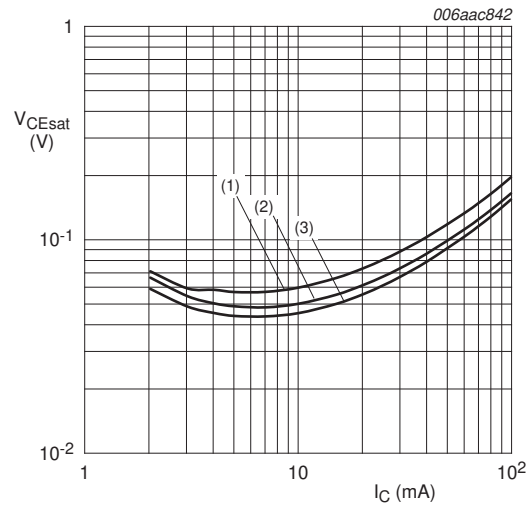

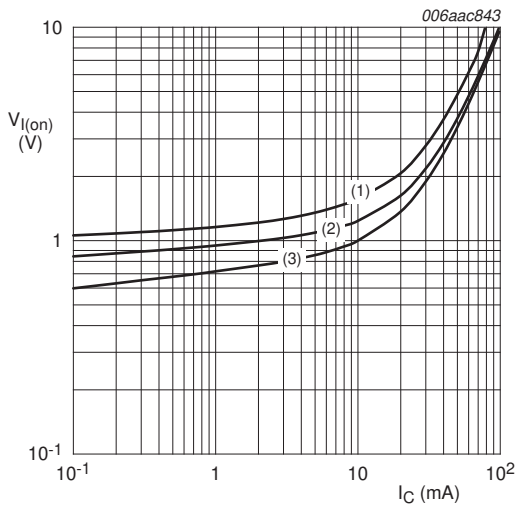

**Fig 4. DC current gain as a function of collector current; typical values**



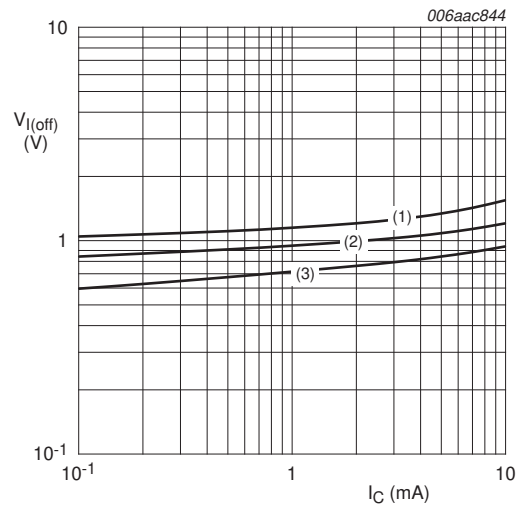

**Fig 5. Collector-emitter saturation voltage as a function of collector current; typical values**



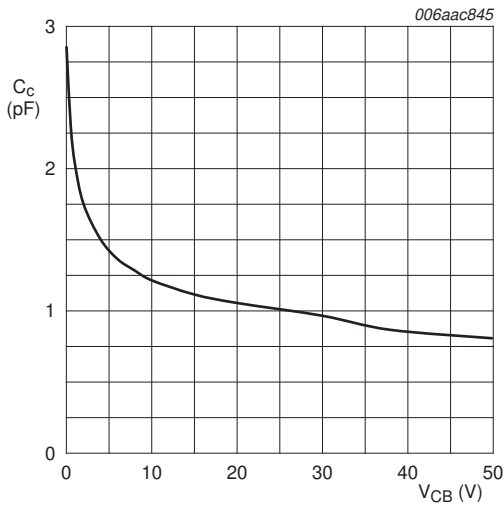

**Fig 6. On-state input voltage as a function of collector current; typical values**



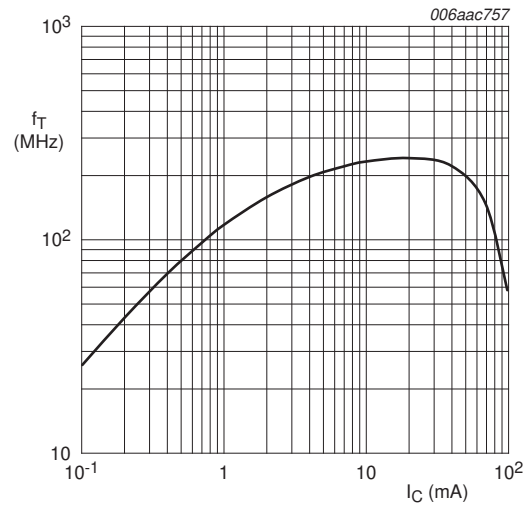

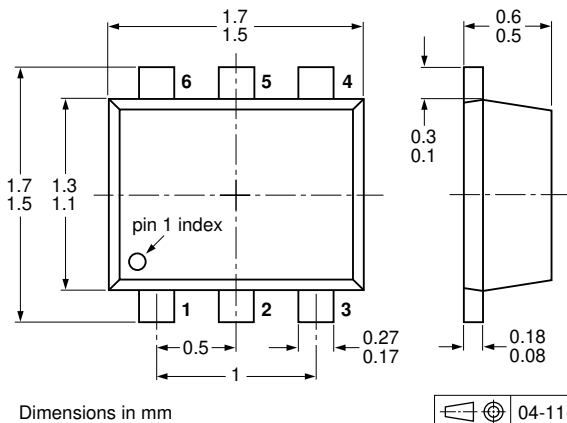


Fig 10. Package outline PEMH18 (SOT666)

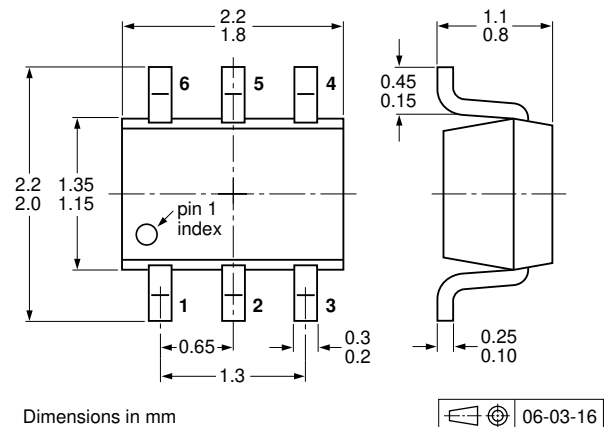


Fig 11. Package outline PUMH18 (SOT363)

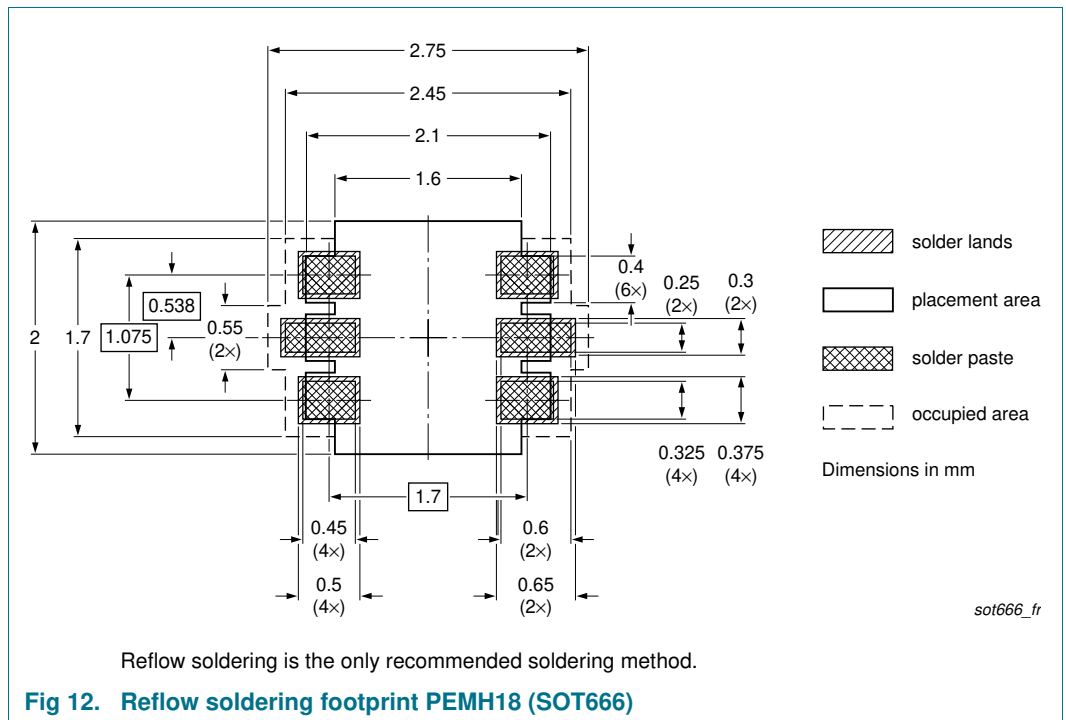

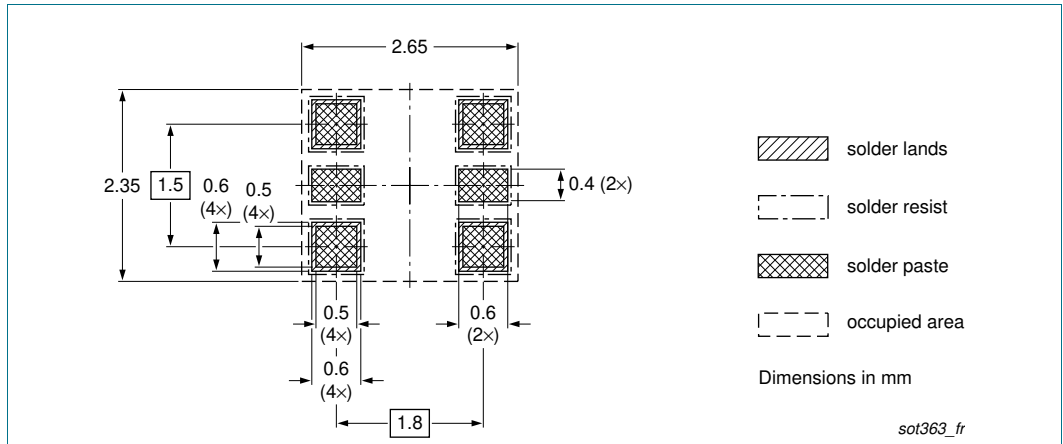

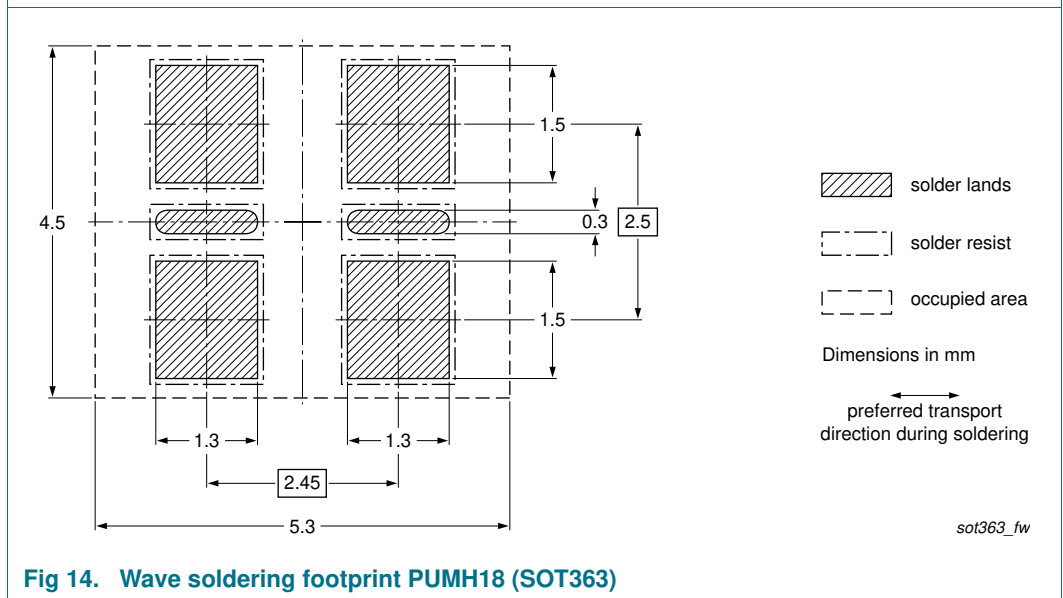
