





Fig.2 Typical outpur characteristics




COLLECTOR TO EMITTER VOLTAGE : $V_{\text{CE}}\left[V\right]$

Fig.4 DC current gain vs. collector current (II)






Fig.7 Base-emitter saturation voltage vs. collector current






Fig.6 Collector-emitter saturation voltage vs. collector current (II)

Fig.9 Emitter input capacitance vs. emitter-base voltage Collector output capacitance vs. collector-base voltage






Fig.10 Safe Operating Area


