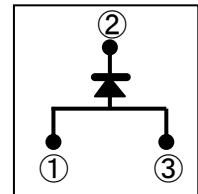

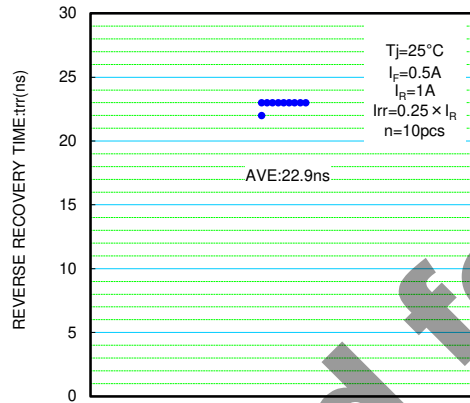

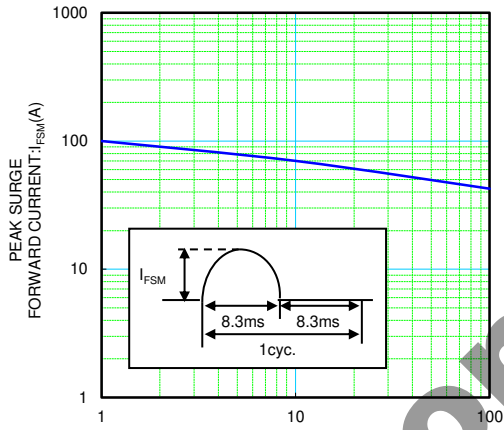




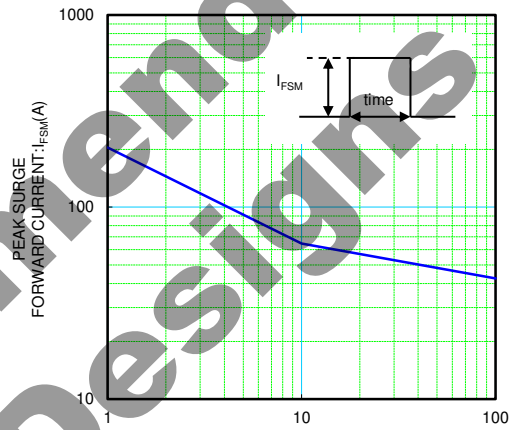
IFSM DISPERSION MAP



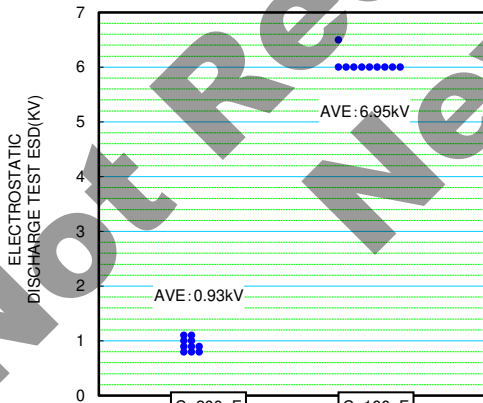
trr DISPERSION MAP



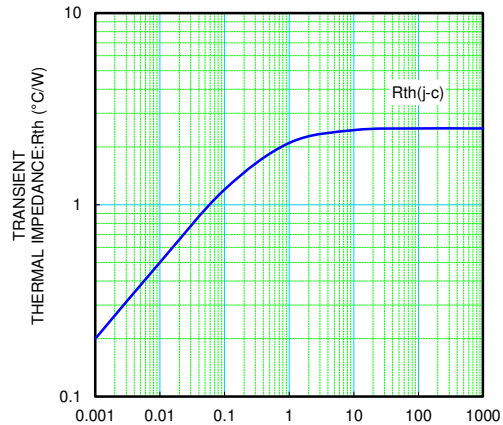
IFSM CYCLE CHARACTERISTICS



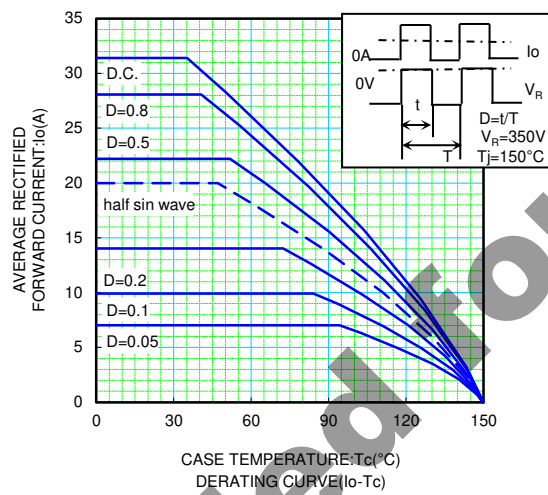
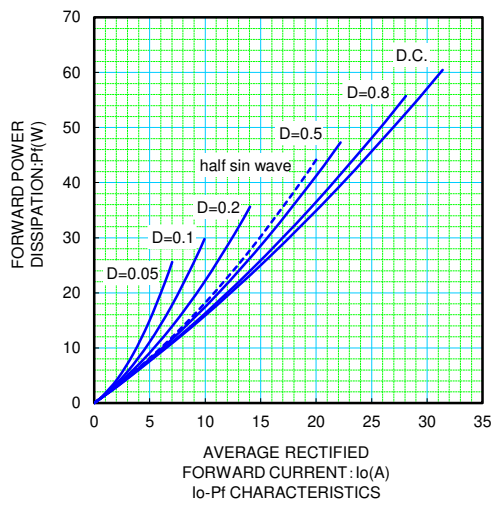
IFSM-t CHARACTERISTICS
