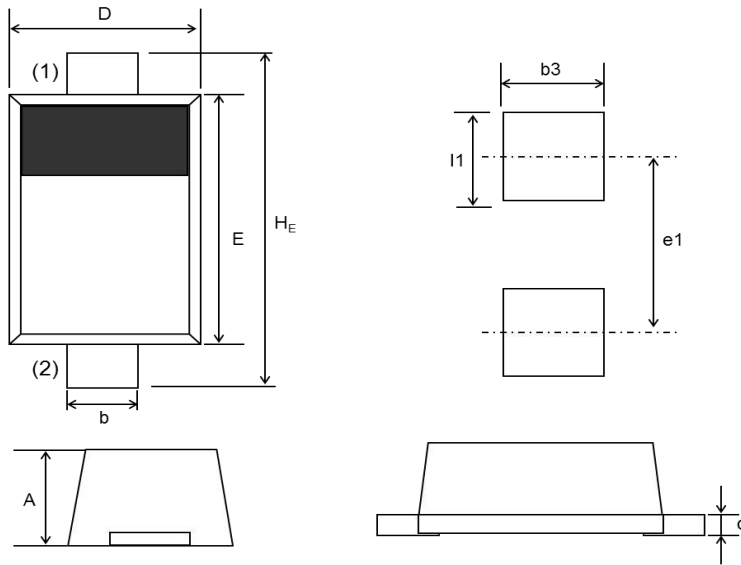
● Electrical Characteristic Curves

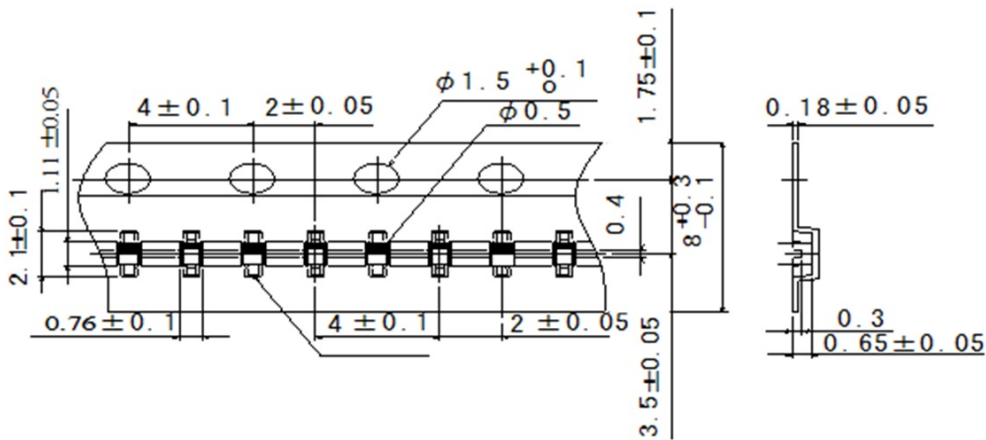
