Fig.1 Forward Current Derating Curve




Fig.2 Typical Junction Capacitance




Fig.3 Typical Reverse Characteristics





Fig.4 Typical Forward Characteristics

Fig.5 Maximum Non-repetitive Forward Surge Current






Fig.6 Reverse Recovery Time Characteristic And Test Circuit Diagram









