


Figure 1a. Average Forward Current Derating Curve




Figure 1b. DC Forward Current Derating Curve




Figure 2. Reverse Current vs. Reverse Voltage




Figure 3. Typical Reverse Characteristics




Figure 4. Forward Voltage vs. Forward Current




Figure 5. Typical Junction Capacitance
