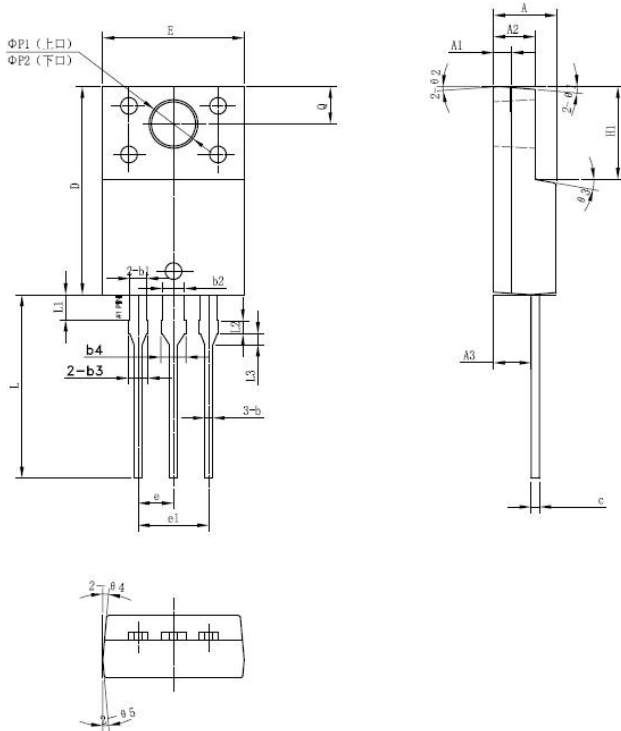

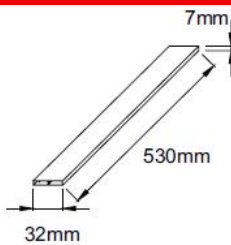


Mechanical Dimensions ITO-220AB

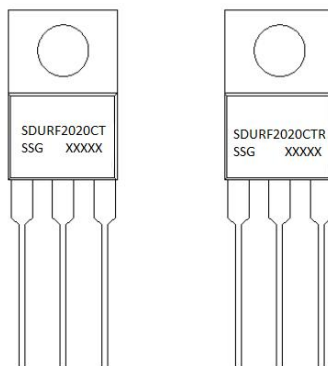
