




Fig. 1 - Switching Waveform and Switching Schematic




Fig. 2 - Collector Current (mA) vs. Forward Current (mA)




Fig. 3 - Collector Current vs. Forward Current




Fig. 4 - Collector Current vs. Ambient Temperature




Fig. 5 - Collector Current vs. Collector Emitter Voltage




Fig. 6 - Collector Emitter Dark Current vs. Collector Emitter Voltage over Temperature




Fig. 7 - Current Transfer Ratio vs. Forward Current




Fig. 8 - Normalized CTR vs. Temperature





Fig. 9 - Switching Time vs. Load Resistor
