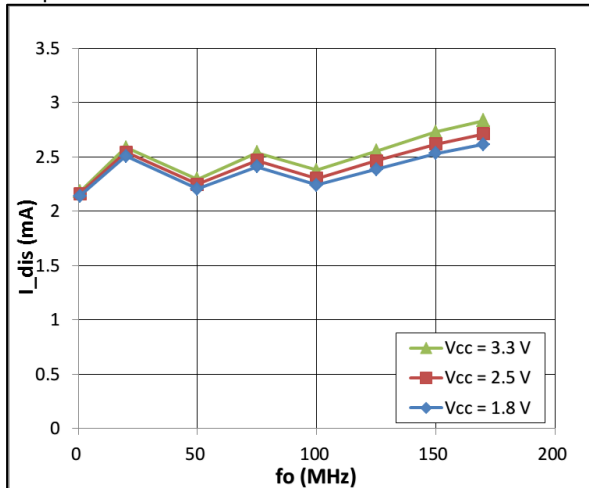

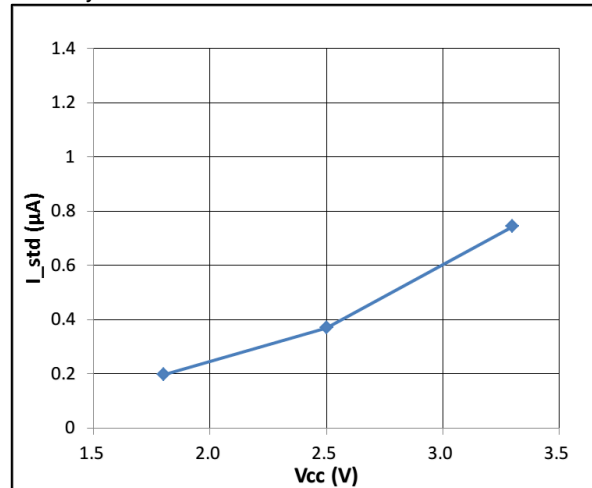
Current Consumption

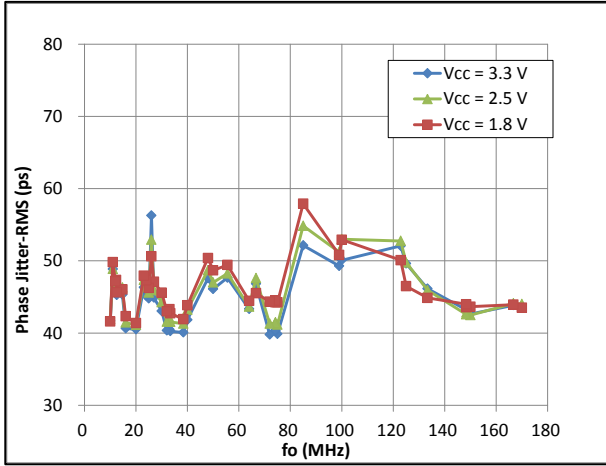

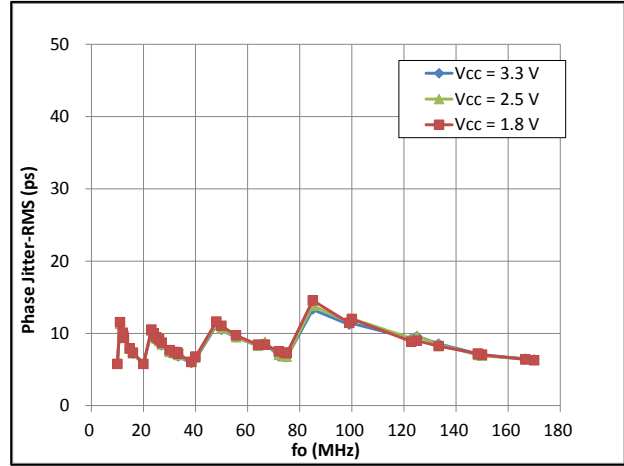
Phase Jitter RMS

(Integration bandwidth 12 k–20 MHz)

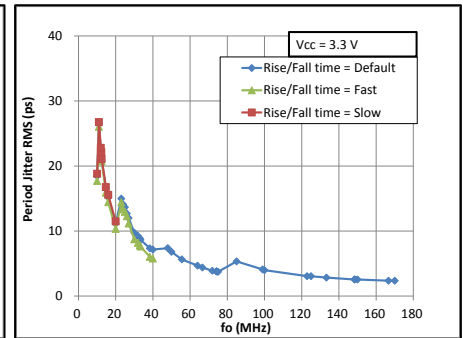
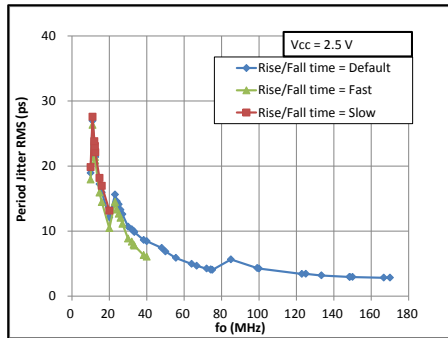
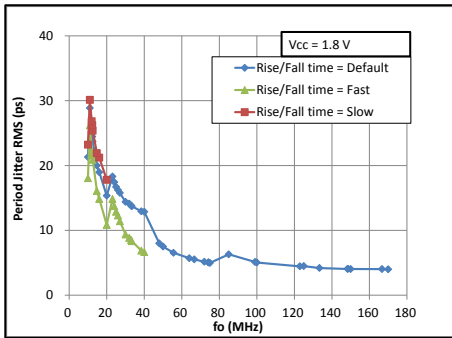

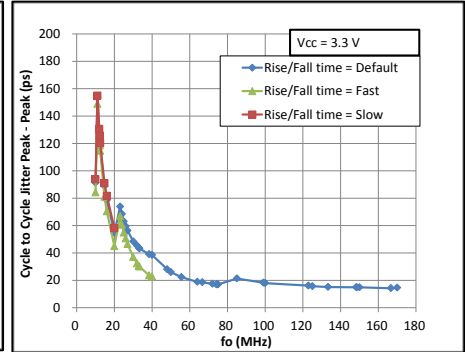
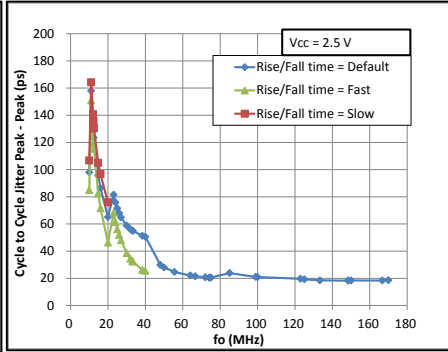
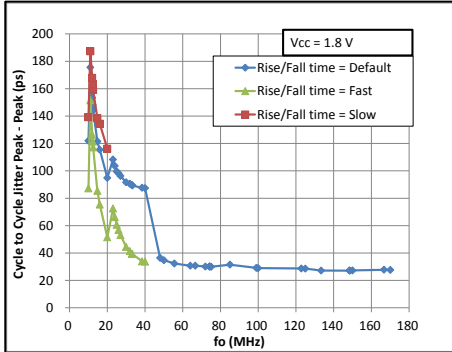
Period Jitter RMS

Cycle-to-Cycle Jitter Peak-Peak

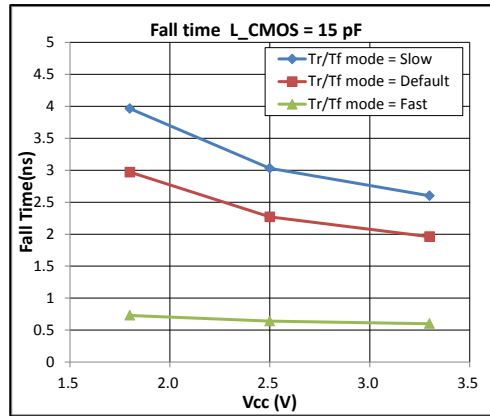
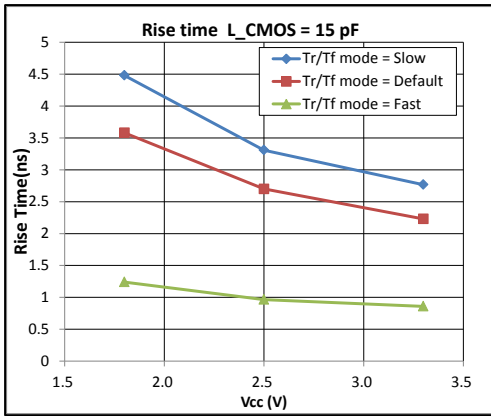
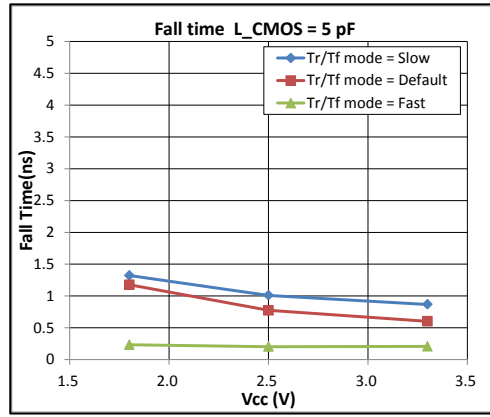
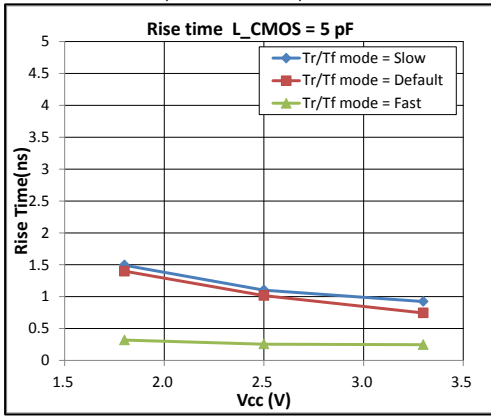

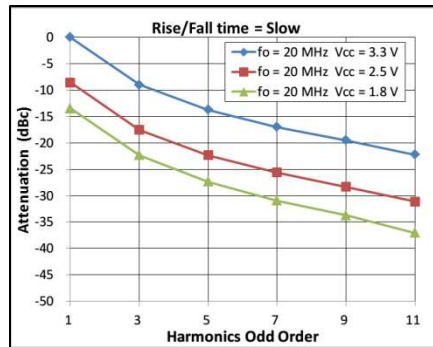
Harmonics spectrum ( $f_o = 20\text{ MHz}$ )



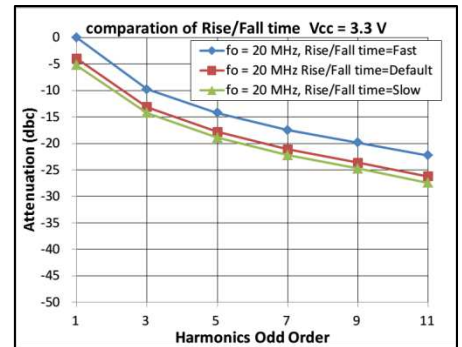
Harmonics comparison

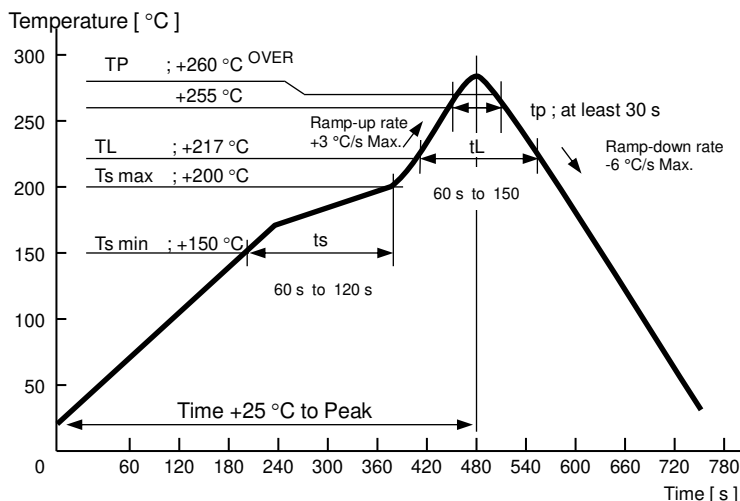

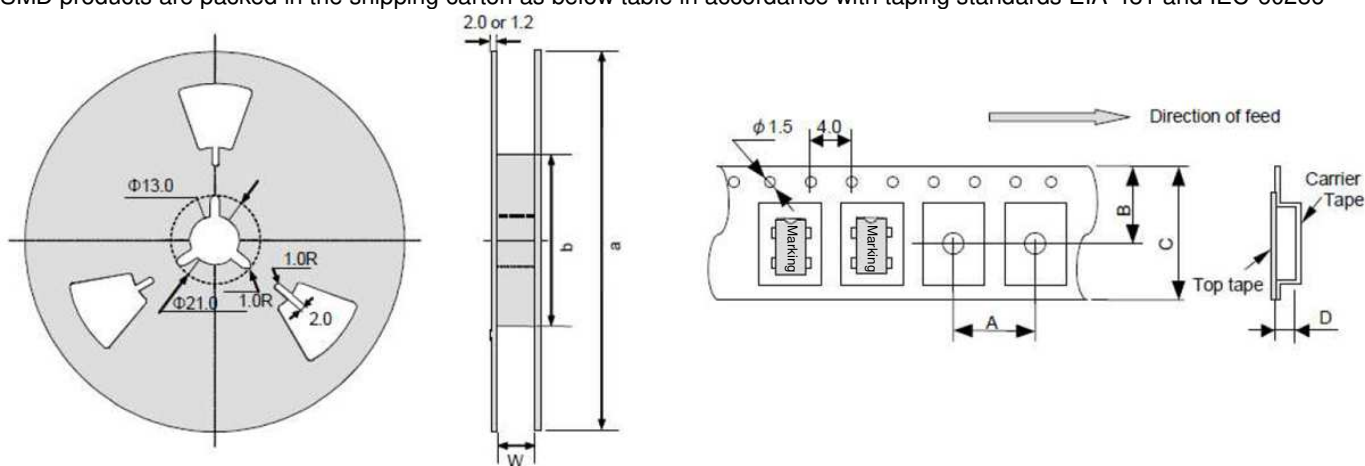
