Recommended PCB Layout Top View



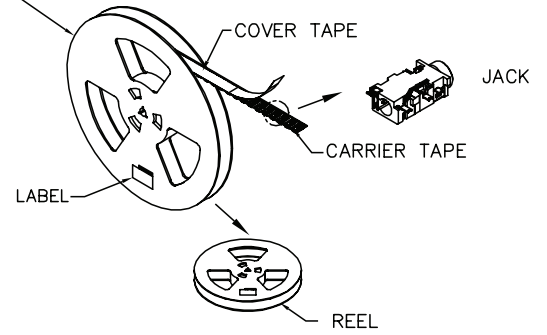
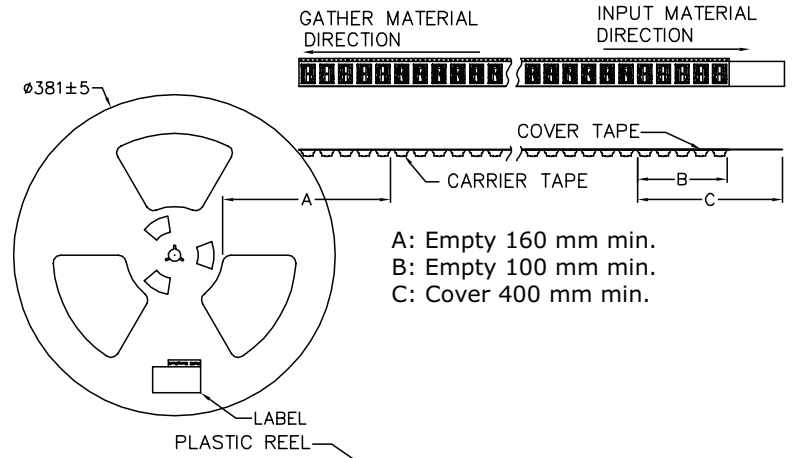
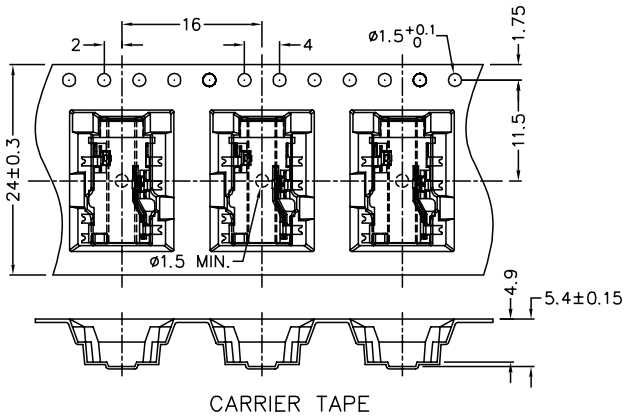
