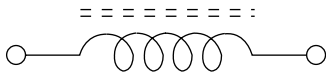

Electrical Schematic

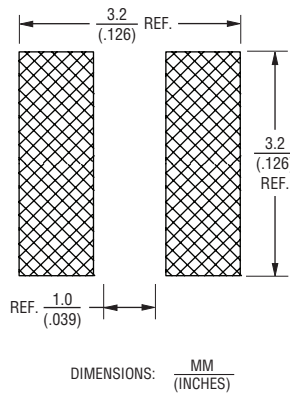

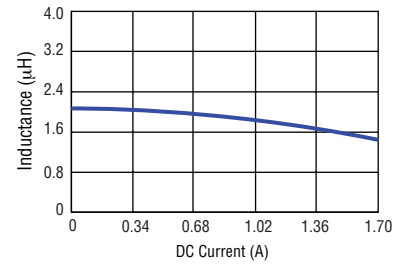
