The TLP105 has an internal Faraday shield, which provides a guaranteed common-mode transient immunity of  $\pm 10 \text{ kV/}\mu s$ .














### **Test Circuit 7: Switching Time Test Circuit**




### **Test Circuit 8: Switching Time Test Circuit**
