




Fig. 10.1 Switching Time Test Circuit and Waveform






12. Soldering and Storage

12.1. Precautions for Soldering

The soldering temperature should be controlled as closely as possible to the conditions shown below, irrespective of whether a soldering iron or a reflow soldering method is used.






12.2. Precautions for General Storage


Fig. 15.1 EN60747 Insulation Characteristics






Fig. 15.3 Marking Example (Note)






Fig. 16.3.5.1	Tape dimensions









Fig. 16.4.2 10 reel/carton (unit: mm)


