



Fig. 12.1.1 IOH Test Circuit




Fig. 12.1.2 V_{OL} Test Circuit





Fig. 12.1.4 I_{CCL} Test Circuit



P.G.: Pulse generator









Fig. 12.1.6 Common-Mode Transient Immunity and Waveform

13. Soldering and Storage






13.2. Precautions for General Storage

- Avoid storage locations where devices may be exposed to moisture or direct sunlight.
- Follow the precautions printed on the packing label of the device for transportation and storage.
- Keep the storage location temperature and humidity within a range of 5 °C to 35 °C and 45 % to 75 %, respectively.
- Do not store the products in locations with poisonous gases (especially corrosive gases) or in dusty conditions.
- Store the products in locations with minimal temperature fluctuations. Rapid temperature changes during storage can cause condensation, resulting in lead oxidation or corrosion, which will deteriorate the solderability of the leads.


Fig. 16.1 EN60747 Isolation Characteristics





Fig. 16.3 Marking on Packing


