



Fig. 12.1.1 IOH Test Circuit




Fig. 12.1.2 V_{OL} Test Circuit





Fig. 12.1.4 I_{CCL} Test Circuit

Fig. 12.1.5 Switching Time Test Circuit and Waveform







Fig. 12.1.6 Common-Mode Transient Immunity Test Circuit and Waveform






13.2. Precautions for General Storage
