


Fig. 1 - Power Dissipation Limit vs. Ambient Temperature




Fig. 2 - Collector Dark Current vs. Ambient Temperature




Fig. 3 - Collector Light Current vs. Irradiance




Fig. 4 - Rise/Fall Time vs. Collector Current




Fig. 5 - Relative Spectral Sensitivity vs. Wavelength




Fig. 6 - Relative Radiant Sensitivity vs. Angular Displacement




Fig. 7 - Relative Collector Current vs. Ambient Temperature

### **REFLOW SOLDER PROFILE**




Fig. 8 - Lead (Pb)-free Reflow Solder Profile acc. J-STD-020
