

The VO3052 and VO3053 triac driver family consists of a GaAs infrared LED optically coupled to a monolithic photosensitive non-zero crossing triac detector chip.






Fig. 1 - Forward Voltage vs. Forward Current




Fig. 2 - Off-State Leakage Current vs. Temperature




Fig. 3 - On-State Current vs. V<sub>TM</sub>




Fig. 4 - Normalized Trigger Current vs. Temperature




Fig. 5 - Turn-on Time vs. LED Current




Fig. 6 - Normalized Holding Current vs. Temperature




Fig. 7 - Turn-on Time vs. Temperature





Fig. 8 - Trigger Current vs. Pulse Width
