






Fig. 1 - Timing Schematic





Fig. 2 - Safety Input Current vs. Ambient Temperature








Fig. 4 - Maximum Load Current vs. Ambient Temperature




Fig. 5 - Forward Voltage vs. Ambient Temperature




Fig. 6 - Forward Current vs. Forward Voltage





Fig. 7 - Normalized Forward Current for Switch Turn-On vs. Ambient Temperature

Fig. 8 - Normalized On-Resistance vs. Ambient Temperature




Fig. 9 - Output Capacitance vs. Load Voltage




Fig. 10 - Off-State Leakage Current vs. Load Voltage




Fig. 11 - Turn-On Time vs. Forward Current




Fig. 12 - Normalized Turn-On Time vs. Ambient Temperature




Fig. 13 - Turn-Off Time vs. Forward Current





Fig. 16 - VOR1142M4




Fig. 18 - Lead (Pb)-free Reflow Solder Profile According to J-STD-020 for SMD Devices
