100V INPUT, 8.2V 30mA REGULATOR TRANSISTOR


Description

The ZXTR2008Z monolithically integrates a transistor, Zener diode and resistor to function as a high voltage linear regulator. The device regulates with an 8.2V nominal output at 15mA. It is designed for use in high voltage applications where standard linear regulators cannot be used. This function is fully integrated into a SOT89 package, minimizing PCB area and reducing number of components when compared with a multi-chip discrete solution.





Typical Application Circuit




Example of an 8.2V regulated supply from a nominal 48V for powering a Controller IC.

Pin Functions

Pin Name	Pin Function	Notes	
V _{IN}	Input Supply	Input voltage can vary from -0.3V to 100V with respect to GND; for V_{OUT} regulated then $12V \le V_{IN} \le 100V$. It is recommended to connect a $1\mu F$ capacitor to GND.	
GND	Power Ground	This pin should be tied to the system ground.	
V _{OUT}	Voltage Output	Outputs a regulated 8V when $12V \le V_{IN} \le 100V$. When $V_{IN} < 12V$, then V_{OUT} maximum = $V_{IN} - 1.5V$. The pin can be pulled high to a maximum of +14V with respect to GND, or +8V with respect to V_{IN} , whichever is lower. It is recommended to connect a $10\mu F$ capacitor to GND and a minimum of $10\mu A$ to be drawn from V_{OUT} to maintain regulation.


